
With due respect and humble submission, I ASI. Kanak Das of Matigara P.S do hereby lodge this written complaint to the effect that today on 15/10/2025. I was deputed to perform mobile patrolling(K-32 Van) duty along with C/974 Mintu Sen and C/ 225 Arun Kr. Roy, since 08:00 hrs. vide Matigara P.S. C.C. No. 2777/2025, Dated 15/10/2025 and Matigara P.S. GDE No. 732, Dated 15/10/2025. In course of said mobile duty I received a source information that one vehicle is coming from Balasan River loaded with River bed Materials towards Khaprail More under Matigara PS, which was procured clandestinely. On receipt of such information, I informed the matter to I/C Matigara PS over phone and as per his kind direction myself along with force rushed to Balasan River side and on way at Ram Krishna Para under P.S. Matigara we found one Vehicle (Mini Dumper) bearing Regn. No. **WB/73 G 3328** loaded with river bed materials in a high speed running towards Siliguri Side, we tried to detain the said vehicle but seeing Police Mobile Van the driver/owner of said vehicle (Mini Dumper) jumped from the vehicle and flee way towards Balasan River side. It is crystal clear that the driver of the vehicle (Mini Dumper) bearing Regn. No. **WB/73 G 3328** procures the river bed materials from somewhere clandestinely and illegally and was preceding to sale the same to their designated customer for their wrongful gain. Nobody came forward to claim the said loaded Tractor. I asked to the local people about the abandoned Mini Dumper having Regn No. **WB/73 G 3328** but they could not give any satisfactory reply. Accordingly, I seized the vehicle (Mini Dumper) bearing Regn. No. **WB/73 G 3328** loaded with River Bed Materials on the spot i.e. Ramkrishna Para, P.S. Matigara as abandoned condition by maintaining all formalities and prepared proper seizure list in presence of witness. Brought the seized vehicles to Matigara P.S and kept at P.S Compound. The whole process of Seizure was made in between 12.08 hrs to 12.13Hrs.

I therefore pray before you that a specific case under proper section of Law may kindly be started against the accused driver as well as owner of the seized vehicle bearing no. Regd No. WB/73 G3328 and arrange for its investigation.
