
Subject: F.I.R

Sir

With due respect and humble submission I A.S.I Subhash Bdr. Tamang of Matigara P.S. Siliguri Police Commissionerate, do hereby lodge this written complaint to the effect that on 15.10.2025 I was deputed to perform Mobile Van K 32 duty along with force since 13.55 hrs, vide C.C. No. 2782/25, Dated 15.10.2025 and GDE No. 749, Dated 15.10.2025 in the said mobile van duty I received source information that one Dumper is coming from Tarabari towards Phansidewa Underpass side under Matigara PS loaded with river bed material which were procured clandestinely Accordingly I informed the matter to I/C Matigara P.S over phone, he immediately directed me to work out the information in hand. Accordingly, I along with force rushed to " Phansidewa underpass side and intercepted one Dumper truck bearing No. WB71 B- 5742 loaded with river bed materials near Phansidewa underpass under Matigara PS Dist Darjeeling. Seeing the police party the driver/owner of said Dumper fled away. It may be presumed that the Driver/Owner of said Dumper procured the loaded riverbed materials, illegally and dishonestly, stealing by unfair means from somewhere, for his wrongful gain and to deliver the same to their designated customer. I searched for the Driver/Owner of the said Dumper in the surrounding areas but in vain. Nobody came forward to claim the said Dumper loaded with riverbed Materials. Finding no other alternatives, I seized the Dumper truck bearing Regn No. WB71 B- 5742, loaded with river bed materials, preparing proper Seizure List and brought it to PS Compound. The whole process of search and seizure were made in between 22.00 hrs to 22.11 hrs on 15.10.2025 under proper videography in E- Shakshya.

Therefore, I pray before your kind honour that a specific case may kindly be registered against the driver/owner of vehicle No. WB71 B- 5742 loaded with river bed materials, and arrange for its investigation.
