Respected Sir,

- I, Pradeep Kumar Agarwal, son of Late GajanandAgarwal, resident of C/O Sakhi Emporium Shivaji Road, Khal Para, P.O & P.S-Siliguri, District- Darjeeling, do herby lodge this written complaint against the above named accused person(s) for extortion, damage to property and forgery of public record, the factual aspects which needs appreciation are as follows:
 - That, the above named accused person(s) in connivance with each other have forged and procured numerous deeds/records of rights and on the basis of which they tried to extort the actual owner of the land in and around the Binnaguri mouza under New Jalpaiguri Police Station.
 - 2. That, I along with uncle namely Prahlad Roy Agarwal, instituted a title suit being No. 09 of 2005, against the accused person No. 1 and 2 herein above, and on 05.12.2016 the Ld. Civil Judge Junior Division Court at Jalpaiguri, passed final order being Order No. 78 dated 05.12.2016 and subsequently a decree was prepared on 05.12.2016 and signed on 19.12.2016, the order No. 78 dated 05.12.2016 followed by decree Clearly and loudly confer the right, title, interest of the suit property to and in favour the plaintiff/complainant of this

written complaint, which has attain its finality as the accused No. 1 and 2/ defendant No. 4 and 5 have never challenge such order and decree.

- 3. That, subsequently I, got share of my uncle namely Prahlad Roy Agarwal, by way of Gift vide document No. I-4138 of 2022 and I became the exclusive and absolute owner of the property. That the above named accused person(s) along with Sudan Roy, son of Late Kala Roy in connivance with Naresh Roy by preparing a forge documents, now tried to extorted money to the tune of Rs. 25,00,000/- (Twenty Five Lac) only, from me and for that reason I have instituted CIVIL Suit being No. 672 of 2025 just before a day of closing of Civil Court in and around state of West Bengal, wherein the Ld. Civil Judge Junior Division 1st Court at Jalpaiguri, after going through the pros and cons of the suit record prima facie hold that I/plaintiff is the owner in possession having right/title/interest on the suit property and also restraint the defendant(s)/accused person(s) from disturbing me in any manner whatsoever.
- 4. That, taking the advantage of the vacation of the court, the accused person(s) along with other 32 to 40 anti-social persons today i.e. 13.10.2025 at around 7:15 to 7:45 A.M, vandalized my construction and dishonestly take away building raw materials (Iron Rods worth of Rs. 8,00,000/- (Eight Lac) only, the activities of the vandalism is being captured in the C.C.T.V camera installed thereat, it is pertinent to mention, that at about 8:30 A.M., I rush to my property wherein the accused persons namely 1. MD. Abdul kader, and 2. MD. Ali Baksh, and 3. Sudan Roy, blatantly demanded Rs. 10,00,000/- (Ten Lac) only, from me to return back the buildings materials and Rs. 40,00,000/- (Forty Lac) only, for amicable settlement whereby they accused person(s) shall not disturb my peaceful possession. Such demand is absolutely illegal and should not encourage in a civilized society.

5. That the said accused persons along with others hit me with fist and blows and also hit me with the iron rod from the back with a pure intention to kill me. Due to the injury in my head I am constantly vomiting and falling unconscious time and again.

6. That, they also attacked my security guard/gatekeeper with deadly weapons Khukuri, and a sharp knife as the guard was trying to save me from them. They have also snatched a gold chain from my neck which values worth over 2,00,000/- (Two Lac) only.

7. The said persons claim themselves to be very powerful and influential persons and say that they do not fear authority neither to the law. Many of the accused persons are habitual offenders out of the said accused persons.

> Under the above facts and circumstances your good office hereby requested to take strict/necessary legal action against the accused person(s) in accordance with law and recover the building materials and save me from the said accused persons as my life is at risk from the above named accused persons.
