Sir,

I, SI Ganesh Roy of Detective Department, SPC do hereby producing one arrested accused person namely Sumon Roy (M/24) S/O Ranjit Roy of Saktigar, Road No-05, Ward No-31, PO- Siliguri Bazar, PS- NJP, Dist- Jalpaiguri along with seized articles viz 1] 30 bundle of Black Cat Chocolate Bomb, each bundle containing 05 packets (30 X 5 = 150 Packets) total weight 15 kg 750 grams, Market Value approx Rs. 15000/- 2] 07 bundle PONS COBRA(Lanka Baji) each bundle containing 50 packets (7 X 50 = 350 Packets) total weight 21 kg, Market Value approx Rs. 7300/- under proper seizure list .

In this regard I beg to complain that today i.e on 15.10.25 at 18.45 hrs received a secret source information that one person was standing at Porajhar road, under NJP PS with huge quantity of different types of banned Fire-crackers for delivering the same to his designed customers at the adjacent areas. This refers to D.D, SPC GDE No. 92 dated 15.10.25. Accordingly, I informed the matter to ACP,DD, SPC. As per order, I accompanied with SI Proloy Bhattacharjee, ASI Sushanta Dey, Const. 670 Ratan Roy, Const 686 Arup Saha, Const 562 Utpal Saha and LC- 1310 Dipika Thapa all of DD, SPC, Siliguri rushed to the spot to work out the information vide D.D, SPC GDE No. 93 dated 15.10.25. I also took investigating kits/materials with me. On reaching at Porajhar road, I contacted with source and as shown by source we are apprehended one person with the above mentioned seized articles (Fire Crackers). On interrogation he disclosed his identity as noted above. On being search I recovered from his possession, 1] 30 bundle of Black Cat Chocolate Bomb, each bundle containing 05 packets (30 X 5 = 150 Packets) total weight 15 kg 750 grams, Market Value approx Rs. 15000/- 2] 07 bundle PONS COBRA(Lanka Baji) each bundle containing 50 packets (7 X 50 = 350 Packets) total weight 21 kg, Market Value approx Rs. 7300/-. On demand he could not produce any documents/licenses in support of the possession of such quantity of Fire Crackers. On question he confessed that he procure the banned fire crackers illegally, and sell the same to the interested persons for his wrongful gain. The accused was carrying such banned fire crackers without any safety measure and without any permission from appropriate authorities, and also violated the order of Hon'ble High Court Calcutta. If any accident took place due to negligent act of the accused person that may cause loss of life and property of the area. The Fire crackers were carrying without any precautionary and safety measure. Accordingly, I seized the fire crackers in presence of witnesses under proper videography and duly signed by the witnesses and accused person. The seizure procedure was done in between 21.10 hrs and 21.45 hrs. Then I arrested the above noted accused person U/S 35 BNSS.

Under the above circumstances, I pray before your kind honour that a specific case may kindly be started against the above noted arrested accused person namely Sumon Roy (M/24) S/O Ranjit Roy of Saktigar, Road No-05, Ward No-31, PO- Siliguri Bazar, PS- NJP, Dist- Jalpaiguri under proper section of law and arrange for its investigation.
