Respected Sir,

I, Kapila Sha, resident of Subhaspally, Bagdogra wish to lodge a complaint regarding a tragic road accident that occurred on Nobomi morning, dated 01/10/2025, at around 4:28 a.m. in front of Honda Showroom (Medical More), Matigara.

At that time, an unknown number vehicle hit a motorcycle from behind on which two boys were riding. Due to the severe impact, both riders fell on the road with serious injuries. The vehicle driver did not stop and fled the scene immediately after the collision.

The injured persons were taken to North Bengal Medical College for medical assistance. Unfortunately, my son succumbed to his injuries and passed away, while the other boy remains under treatment.

The details of the victim are as follows :

As the vehicle number could not be noted in the chaos, I request you to kindly register this case, investigate the incident, trace the offending vehicle and its driver, and take necessary legal action.
