Sir,

In producing herewith one arrested accused person namely Jayanta Barman (S/O- Suresh Barman) in Charge
S/O- Suresh Barman of Guria Jote, PO- Nema, PS-Matigara, Dist-Darjeeling Matigara Police Station
following seized articles under proper seizure list - Siliguri Police Commissionerate

1] Forty (40) packets of 'KING COBRA' marked Electric fire crackers containing Twenty Six (26) piece in each packet, 2] Forty Five (45) packets of 'JUGMUG' marked chocolate fire crackers containing Twelve (12) pieces in each packet, 3] Twenty Five (25) packets of 'RHINO POWER' marked chocolate fire crackers containing Ten (10) pieces in each packet, (In total 6.6 Kg in weight).

I, ASI Bikash Roy of Matigara Police Station, Siliguri Police Commissionerate do hereby lodged this written complaint to the effect that today on 17.10.2025 at 18:05 hrs I received a secret information that one Jayanta Barman (22yrs), S/O- Suresh Barman of Guria Jote, PO- Nema, PS-Matigara, Dist-Darjeeling has stored huge quantity of Fire-crackers at his shop styled as Sarat Store at Guria Jote for selling the same in the open market for his wrongful gain without having any license or any other valid documents in respect of the same, violating the provision of law which may endanger human life and likely to cause injury of human life. This refers to Matigara PS GDE No- 886, dated- 17.10.2025. Accordingly, as per your kind order of I/C PS, I along with ASI Diapk Kr. Chhetri, ASI Chandra Prakash Adhikari, C/868 Sujal Roy, C/523 Sanjit Kundu all are of Matigara PS, SPC rushed to the spot to work out the information.

On reaching at Guria Jote, under Matigara PS I contacted with my source and being guided and identified by the source we proceeded towards the shop styled as Sarat store of the above noted accused person. Accordingly, I searched his shop in presence of local witnesses and found the above noted seized articles being stored in his shop without any precautionary and safety measures. On being asked Jayanta Barman could not produce any valid document for above mentioned fire crackers. Accordingly I seized the above noted articles with the help of my police team under proper seizure list in presence of independent witnesses and arrested the above noted accused person namely Jayanta Barman (22yrs), S/O- Suresh Barman of Guria Jote, PO- Nema, PS-Matigara, Dist-Darjeeling under proper memo of arrest.

There is a reason to believe that Jayanta Barman (22yrs), S/O- Suresh Barman of Guria Jote, PO- Nema, PS-Matigara, Dist-Darjeeling has stored the said consignment of fire crackers for selling the same in the open market for his wrongful gain, which are combustible in nature and endanger to human life and property at his shop illegally and violating Govt. Orders. Moreover, the above noted fire crackers were stored without any precautionary and safety measures. Accordingly, I seized the above noted fire crackers under proper seizure list duly signed by the witnesses and arrested the above noted accused person. The whole process of seizure and arrest were made between 18.50 hours to 19.07 hours under video graphy through E-Shakshya app.

Under the above fact and circumstance, I pray before you that a specific case may kindly be started against the arrested accused person namely Jayanta Barman (22yrs), S/O- Suresh Barman of Guria Jote, PO- Nema, PS-Matigara, Dist-Darjeeling, under proper section of law and arrange for its investigation.
