In producing herewith one arrested accused person, namely Johar Saha (52), s/o- Lt. Shyamanical Editional Saingage was a Constitute of the Commissioneral Gossaingaon ward no. 4, Gossaigaon, Kokrajhar, Assam, -783360, A/P- of Saratchandra Pally, Buddha Mandir Road, PO-Haiderpara, PS-Bhaktinagar, dist-Jalpaiguri, under arrest and following seized articles under seizure

I, SI Agen Lepcha, s/o Lt. Dup Tshering Lepcha, of Ashighar Out Post under Bhaktinagar Police Station, Siliguri Police Commissionerate, hereby file a formal complaint against Johar Saha. On 17/10/2025 at 19:30 hrs, I received reliable information that Johar Saha has unlawfully stored a substantial quantity of firecrackers at his shop styled as Lokenath Book Store, Fakdaibari, PS Bhaktinagar, Dist. Jalpaiguri. His intention to sell these firecrackers in the open market for personal gain, without any license or valid documentation, constitutes a serious violation of the law and poses a significant threat to human life.

This matter is diarised in Ashighar OP GDE No. 515 dated 17/10/2025. Accordingly, informing the matter to O/C Ashighar OP, I, along with ASI Dinesh Chandra Roy, C/970 Bikash Roy, C/1547- Prabir Das, and CV/603 Arun Roy from Ashighar OP, proceeded to the location to verify the veracity of source information.

En route to Hatiadanga, I summoned one impartial witness: (i) Pulin Das (55) s/o Lt. Satyanand Das of Fakdaibari, PO- Goghomali, PS Bhaktinagar, Dist. Jalpaiguri. I briefed him about the ongoing situation, and he willingly agreed to assist us during the raid, search, and seizure operation.

Upon arrival at Fakdaibari, I established contact with my source, who guided us to the premises. We entered the shop and apprehended Johar Saha, along with the firecrackers stored there. During questioning, he could not provide a satisfactory answer for storing the huge quantity of firecrackers in his shop. He failed to produce any valid documents or a license to justify his possession of such a considerable quantity of firecrackers. The evidence strongly indicates that he has unlawfully stored these firecrackers for sale in the open market, directly violating Sections 287 and 288 of the Bharatiya Nyaya Sanhita, thereby endangering public safety.

Accordingly, I seized the above-noted firecrackers under the proper seizure list, signed by the witnesses and acknowledged by Johar Saha, with the entire process recorded on video. This seizure was completed between 20:20 hrs and 20:40 hrs. Subsequently, I arrested Johar Saha, following all necessary protocols and informing

In light of these facts, I pray before you that a specific case may kindly be initiated against Johar Saha (52), S/O- Lt. Shyamapada Saha, of Gossaingaon ward no. 4, Gossaigaon, Kokrajhar, Assam, 783360, A/P-Saratchandra Pally, Buddha Mandir Road, PO- Haiderpara, PS- Bhaktinagar, dist- Jalpaiguri, under the applicable sections of the law, and arrange for its investigation.
