I Pramila Sah @ Gupta, the above noted complainant
beg to inform you that on dt. 14.10.2025 at about
09:30 pm, when me & my husband namely, Bikash
Kumar Gupta (39) S/O Lt. Sri Ram Prasad Gupta, both
are of Gwalapatty, were talking with our sister-in-law
namely Gudiya Gupta w/o Sri Ajit Gupta, at our house
at Gwalapatty, at that time her above noted her family
members namely, (1) Parmalik Sah S/O Lt. Jagannath
Sah and his sons namely (2) Arvind Sah (3) Binod
Sah (4) Munna Sah & (5) Arun Sah, all are of Malleguni
noted above, suddenly entered into in our house at
Gwalapatty, and started abusing us in filthy languages
and when my husband & me protested, they started
beating me & my husband brutally with fist & blade
and injured us grievously, and my said sister-in-law
namely Gudiya Gupta @ Sah w/o Sri Ajit Gupta, caught
me by force and the above noted her family members namely
(1) Parmalik Sah & his sons namely (2) Arvind Sah (3) Binod
Sah (4) Munna Sah & (5) Arun Sah, torn off my Kurta
& disrobed me, and the above noted alleged persons
threw my husband on ground and throttled his
neck with intention to kill him.

Sir, the above noted alleged persons are very desperate
& dangerous in nature and they have threatened us for
dire consequences, if we will lodge complain to the police.

Sir me & my husband namely Bikash Kumar Gupta,
immediately shifted to Siliguri Distt. Hospital and treated
ourselves there. So, please take necessary action against them
