I Vivek Sahani, the above noted complainant beg to
inform you that on Dt. 17.10.2025, at about 01:30 am
at night, when me and my parents namely, Sri Rambilash
Sahani S/o Lt. Kari Sahani (a Smt. Ruma Sahani (42) S/o Sri
Rambilash Sahani, & my wife namely, Smt. Bandhan Sahani
(12), were at our house at Santosh Nager, at that
time, I saw my relative namely, ~~Pintu Sahani~~
Pintu Sahani S/o Lt. Ramprakash Sahani, then I demanded
my Rs. 500/- (Five hundred) only from him then he and
his wife, namely Kanchan Sahani, started abusing me
in filthy languages, and when my above noted parents
& wife protested, the above noted alleged persons,
started beating me brutally with fist & blows and
the above noted my relative namely, Pintu Sahani
suddenly took tooth bite on my cheek.

The above noted alleged persons are of very
despotic & dangerous in nature and my father Sri Ram-
bilash Sahani & father of Pintu Sahani namely Lt. Ram-
prakash Sahani are both the sons of Lt. Kari Sahani
and are blood brothers in relation; and the above
noted alleged persons have threatened us for dire
consequences.

I immediately shifted to Siliguri Distt. Hospital
& treated myself there.

So, please take necessary action against above
noted alleged persons
