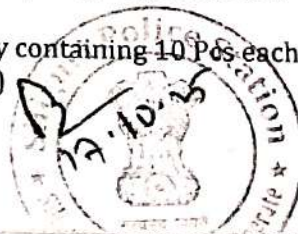

In producing herewith the arrested accused person namely Pranob Roy (55 yrs) S/O Late Shanti Narayan Roy of Rabindra Nagar near Rabindra Sangha Club, ward no.21, PS- Siliguri, Dist- Darjeeling under arrest along with following seized articles as per seizure list viz:-

1. 10 packets of Black Cat Chocolate Bomb ( Electric Sound, mfg by PEW Howrah, Chandan Fire Works containing 10 Pcs each, weighing about 0.962 grams.
2. 08 Pkts of Jawan Colour Koti Fire Crackers authorised name Flower Pots class 01 Div-2 Sub Div-1 & 2 containing 10 pcs each, weighing about 04.217 KG
3. 05 PKTS of Vadivel Fire Works industries Flower Pots Glant, mfg by Vadivel Fire Works industries ( Fire Crackers), Sivakashi containing 10 pcs weighing about 1.625 KG
4. 11 Pkts of Supreme deluxe Fire Crackers ( Chorki )mfg by Fire works and Company ( Unit-V), Sivakashi containing 10 pcs, weighing about 2.684 KGs
5. 05 Pkts of Standard Fire Works Pandav COSMIC Series fire Crackers ,mfg and packed by Standard Fire Works Pvt. Ltd. Containing 05 pcs each, weighing about 2.116 KGs ,
6. 19 Pkts. Of original Colour ; Magic Paper Shot Fire Crackers containing 50 Boxes weighing about 15.635 KGs,

I, ASI Rabin Lama of Siliguri P.S, SPC do hereby lodge this written complaint against accused person Pranob Roy (55 yrs) S/O Late Shanti Narayan Roy of Rabindra Nagar near Rabindra Sangha Club, ward no.21, PS- Siliguri, Dist- Darjeeling to that effect that on 17.10.25 at 20.15 hrs I received a secret source information the above noted person was busy to sale huge quantity of illegal Fire Crackers at Howkers Corner near Railway Gate, ward No.18 under Siliguri PS to his customers for his wrongful gain. This information was diarised in Siliguri PS G.D.E No.1049 dated 17.10.25 and informed the fact to the I/C Siliguri PS. As



per direction of I/C Siliguri PS, myself along with ASI Subir Sen, ASI Minhaj Al Kader, C/160 Soumen Sarkar, all of Siliguri PS left for Howkers Corner near Railway Gate, ward No.18 under Siliguri PS to verify the veracity of this information. After reaching the place of occurrence we cordoned the place and as per identification by source, the above noted person was apprehended who disclosed his identity as noted above and after searching we found the above noted huge quantities of fire crackers was busy to sale to his customer illegally for his wrongly gain. On being asked in presence of available witnesses the above noted accused person failed to produce valid papers or license in support of possessing and selling the above noted huge quantities of fire crackers. On further interrogation, he confessed that he had procured the fire crackers illegally and selling the same in the open market for his wrongful gain which is endanger to human life. According I seized the above noted mentioned firecrackers in presence of witnesses after preparing proper seizure list duly signed by the witness and also acknowledge to the arrested accused person. Then after I arrested him after issuing a Memo of Arrest. The whole seizure was made in between 20.45 hrs and 21.55 hrs. Weight of whole item was approx (TOTAL Weigh = 28.546 KGs). Whole seizure and label was made with Videographed.

I therefore pray before you that a specific case may kindly be initiated against arrested accused Pranob Roy (55 yrs) S/O Late Shanti Narayan Roy of Rabindra Nagar near Rabindra Sangha Club, ward no.21, PS- Siliguri, Dist- Darjeeling under proper section of law.
