In producing herewith the arrested accused person namely Uttam Mallick (41 yrs) S/O Late Ranjit Mallick of Rajiv Nagar, Ward No. 05, PS- Siliguri, Dist- Darjeeling under arrest along with following seized articles as per seizure list viz:-

01. 04 (Four) Bundles of King Kobra Fire Crackers (Lanka Bomb) containing fifty packets each , weighing about 09.031 KGs
02. 07 (Seven) Pkts of original Samim's Rhino power chocolate Bomb containing 10 Pcs each, weighing about 0.611 Kgs,
03. 04 PKTS of Chakkar Asoka Fire Crackers ,mfg by Srikrishna Fireworks Factory (P) Ltd.,898, Kanka Road, Sivakashi containing 10 pcs each , weighing about 0.372 KGs,
04. 08 Pkts of Puppy Chakkar Fire Crackers containing 10 pcs each, mfg by Srikrishna Fireworks Factory (P) Ltd.,898, Kanka Road, Sivakashi, weighing about 2.684 KGs. Total Weight = 10.691 kgs.

I, ASI Debasish Das of Siliguri P.S, SPC do hereby lodge this written complaint against accused person Uttam Mallick (41 yrs) S/O Late Ranjit Mallick of Rajiv Nagar, Ward No. 05, PS- Siliguri, Dist- Darjeeling to that effect that on 18.10.25 at 20.05 hrs I received a secret source information the above noted person was busy to sale huge quantity of illegal Fire Crackers at the Grocery shop of accused person namely Uttam Mallick situated at Rajiv Nagar, Ward No. 05, under Siliguri PS to his customers for his wrongful gain. This information was diarised in Siliguri PS G.D.E No.1101 dated 18.10.25 and informed the fact to the I/C Siliguri PS. As per direction of I/C Siliguri PS, myself along with ASI Subir Sen, ASI Minhaj Al Kader, C/160 Soumen Sarkar , all of Siliguri PS left for Rajiv Nagar, Ward No. 05, under Siliguri PS to verify the veracity of this information. After reaching the place of occurrence we cordoned the place and as per identification by source I found that the above noted accused person was busy to sale fire crackers to his design customer for his wrongly gain. After was apprehending the above noted person who disclosed his identity as noted above. After searching we found the above noted huge quantities of fire crackers was recovered from his exclusives and conscious possession. On being asked in presence of available witnesses the above noted accused person failed to produce valid papers or license in support of possessing and selling the above noted huge quantities of fire crackers. On

further interrogation, he confessed that he had procured the fire crackers illegally and selling the same in the open market for his wrongful gain which is endanger to human life. According I seized the above noted mentioned firecrackers in presence of witnesses after preparing proper seizure list duly signed by the witness and also acknowledge to the arrested accused person. Then after I arrested him after issuing a Memo of Arrest. The whole seizure was made in between 20.35 hrs and 21.45 hrs. TOTAL Weigh is 10.691 kgs. Whole seizure and label was made with Videographed.

I therefore pray before you that a specific case may kindly be initiated against arrested accused Uttam Mallick (41 yrs) S/O Late Ranjit Mallick of Rajiv Nagar, Ward No. 05, PS- Siliguri, Dist- Darjeeling under proper section of law.
