I beg to report that today at around 3.30 pm two persons, one male and one female entered Siliguri Delivery Centre at Siliguri HO premises looking for their article which had been kept in deposit on their instructions. I was about to make delivery of the said article but they had by this time started behaving quite aggressively with me, verbally abused me too. The addressee pulled the Delivery Manifest forcibly from my hand and when I resisted pushed me back too. All this has happened in front of my colleagues who were present there. Sir, since this incident happened within office premises, I request this be treated as FIR. In this altercation the Delivery Manifest and article was also torn which are Government Documents.

Kindly take action on following basis:

1. Assault on duty Government Servant within Office premises.
2. Destruction of Government Documents.

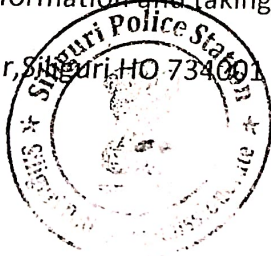
