In producing herewith one arrested accused person namely Abhishek Biswakarma (M/ 19 Years) S/O Lt. Bijoy Biswakarma of Khaprail Bazar, P.S- Matigara, Dist.- Darjeeling along with the following seized articles as per proper scizure list:

06 (Six) packets of 100 flame Gun Fire crackers each packet containing 02 pcs manufactured by Karthik Fireworks.

10 (Ten) packets of Golden Rush Fire crackers each packet containing 05 pcs manufactured by Puja

20 (Twenty) packets of Magic Whip Fire Crackers each packet containing 01 pcs manufactured by

40 (forty) packets of Diamond Green Fire Crackers each packet containing 25 pcs manufactured by

20 (Twenty) packets of The Splendour Great Fire Crackers each packet containing 01 pcs manufactured by Standard Fire Works. (Total weight of all the seized articles approx. 20 kg 200 gram)

I, SI Chiranjit Saha of Khalpara TOP under Siliguri Police Station do here by lodged a written complaint against the above noted accused person named Abhishek Biswakarma (M/ 19 Years) S/O Lt. Bijoy Biswakarma of Khaprail Bazar, J. S. Matigara, Dist.- Darjeeling to the effect that today on 18.10.2025 at 20.55 hrs. I received a credible source information that one person is selling huge quantity of Fire Crackers at Burdwan Road near Karbala under Siliguri Police Station without any vali documents/license. The fact was diarized in Khalpara TOP-II under Siliguri P.S GDE No. 441 Dtd. 18.10.2025. Subsequently, after sharing the information with my superiors and as per their direction, myself along with force of Khalpara TOP left for the place to work out the information. This refers Khalpara TOP-II under Siliguri Police Station GDE No- 442 Dated-18.10.2025.

We reached at the spot at 21.25 hrs. and on being identified by the source our police party able to apprehend the above mentioned accused person with a yellow colour plastic bag at Burdwan Road near Karbala under Siliguri Police Station and recovered the above noted articles i.e (i) 50 (Fifty) packets of Electric Sparklers Fire crackers each packet containing 05 pcs manufactured by Royal Fireworks Industries, (ii) 06 (Six) packets of 100 flame Gun Fire crackers each packet containing 02 pcs manufactured by Karthik Fireworks, (iii) 10 (Ten) packets of Golden Rush Fire crackers each packet containing 05 pcs manufactured by Puja Traders, (iv) 20 (Twenty) packets of Magic Whip Fire Crackers each packet containing 01 pcs , (v) 40 (forty) packets of Diamond Green Fire Crackers each packet containing 25 pcs manufactured by Star Fire Works, (vi) 20 (Twenty) packets of The Splendour Great Fire Crackers each packet containing 01 pcs manufactured by Standard Fire Works - inside the yellow colour plastic bag - from his possession. On demand he unable to produce any valid documents/license in support of said fire crackers and also stated that he was selling the band fire crackers without any valid documents or license violating the provision of law which may endanger human life and likely to cause hurt or injury human or property.

Accordingly, I seized the above noted articles from his possession after preparing proper seizure list in presence of available witnesses and arrested him after maintain all formalities. The seizure was made on 18.10.2025 in between 21.31 hrs. to 21.40 hrs. under videography through WB E-sakshya app.

Under the above circumstances, I request you to start a specific case may kindly be started against the accused person namely Abhishek Biswakarma (M/ 19 Years) S/O Lt. Bijoy Biswakarma of Khaprail Bazar, P.S. Matigara, Dist.- Darjeeling under proper section of law and arrange for investigation.
