Respected Sir,

I Chabbi Begam, wife of Md. Rahman resident of Ashraf Nagar, Budda Mandir Road, Near Kutti Mill, P.O. Haiderpara, P.S. Bhaktinagar, Dist.: Jalpaiguri, beg to state as follows:

1. That today i.e.16/10/2025 around 5:00pm my neighbours namely Md. Manu Haque, his son Moni Haque, his wife Adina Begam and their daughter Jhumpa Khatoon all are resident of Ashraf Nagar, Budda Mandir Road, Near Kutti Mill, P.O. Haiderpara, P.S. Bhaktinagar, Dist.: Jalpaiguri collectively forcefully entered inside my house on a small dispute with regards to the construction of a drain.
2. That they entered into my house with rods, hockey sticks and batams. On being questioned by me as to why have they entered inside my house they started abusing me and my husband namely Md. Rahman and my son Md. Kabir Haque in filthy languages and Moni Haque with hockey stick started beating my son ruthlessly and the said Md. Manu Haque caught hold of my husband's collar and with his hands strangulated him with the intention to kill me on spot.
3. That on seeing and hearing the chaos my daughter namely Rani Khatoon came out from her room whereon she was caught hold off by the said Adina Begam and Jhumpa Khatoon by her hair locke and was dragged by them where on they both started beating her with kicks and blows and the said Moni Haque jumped on top

of my daughter and started touching her in an inappropriate manner and also torn open her clothes in front of everyone present there. That my daughter was wearing a gold chain which was also snatched by the said Adina Begam.

4. That when we all started revolting his such inappropriate action the said Md. Manu Haque and Moni Haque attacked us with rods and hockey sticks because of which we sustained injuries and my son is at present being treated at the Siliguri District Hospital and is in critical condition.

5. That when we raised and cues and cried out for help the said Md. Manu Haque, his son Moni Haque, his wife Adina Begam and their daughter Jhumpa Khatoon ran away from there and the said Md. Manu Haque, his son Moni Haque threatened to kill my son and get my daughter kidnapped and raped if I lodge any complain against him.

Sir the above mentioned are very dangerous in nature and are having the malafide intention to cause harm to my family. I kindly request you to take strict action against the aforesaid culprits.
