
A significant quantity of construction materials have been stolen from the site. As per our initial assessment, we have found 25-30 coils of electric missing from our office room. The estimated value of the material would be approx. 3,00,000 lakhs.

We suspect that the theft took place during the night hours. We kindly request you to register this complaint as an FIR and initiate necessary investigations at the earliest.
