Subject: FIR

Sir,

With due respect I, SI Swapan Singha of Bhaktinagar Traffic Guard hereby lodge a complaint against the driver of a e-Rickshaw (TOTO) bearing registration number WB73F3600.

On 19.10.25 in between 7:30 pm to 8:00 pm while I was on duty at Vishal More, the above mention vehicle was signaled to stop as it was driving in a reckless manner. But the driver ignored my lawful instruction and deliberately hit and dragged me for several meters, causing injuries and endangering the on duty govt. officer's life and safety.

Such kind of behavior amounts to obstruction, assault, and use of criminal force against a public servant while on duty, which is a serious offence under law of the land.

Therefore, it is requested that necessary legal action may kindly be initiated against the said driver and the vehicle involved in the incident as per provision of law.
