- vi) Total 04 (Four) packets of White Green Sparking style as Akash ganga Containing ten Crackers in each Packet.

I, Inspector Prosenjit Das of Enforcement Branch, Siliguri Police Commissionerate do hereby submit a complaint to the effect that today on 18.10.25 at about 13:45 hrs received a source information, that one person without any valid permission or documents made a stock of huge quantity of Banned Sound Fire Crackers in the form of high decibel sound making fire crackers that Banned Sound Fire Crackers having quantity total 10 kgs approxat PurbaDhantala Under New Jalpaiguri PS Dist- Jalpaiguri and are trying to sale items to various customers. Accordingly, I diarised the matter vide EB, SPC GDE No.99, dated 18.10.25 and brought it to the notice of ACP EB, SPC, about the information and as per his direction myself along with ASI Arghya Das and others all of EB, SPC left office to work out the source information. at about 15:35 hrs on 18.10.25 we reached at Purba Dhantala Under New Jalpaiguri PS Dist- Jalpaiguri in the house of Parimal Adhikary and as per identification of source we held raid at that house and found that the above noted fire Crackers was stock in the house of Parimal Adhikary.as a resultthe above noted banned Sound Fire Crackers in the form of high decibel sound making fire crackers as per schedule of West Bengal Pollution Control Board.During enquiry it could be learnt that one Parimal Adhikary S/ONil Kamal Adhikary Purba Dhantala Under New Jalpaiguri PS Dist- Jalpaiguri for selling the above noted fire crackers for making good profit.

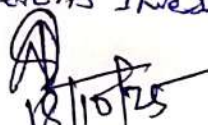
Thereafter I searched and seized procedure from that place in presence of local witness namely 1) Sankar Mandal S/O Lt Hemlal Mondal of PurbaDhantala Under New Jalpaiguri PS Dist- Jalpaiguri and 2) Basudev Adhikary S/O Nil Kamal Adhikary Purba Dhantala Under New Jalpaiguri PS, Dist- Jalpaiguri . During search of the house I found huge quantity around 10 Kgs approx, as noted above of Banned Sound Fire Crackers in the form of high decibel sound making fire crackers for selling locally for making good profit out of these.

Hence, I seized the banned sound fire Crackers as well as under proper seizure list. Seizure was made between 16:05 hrs & 16:45 hrs as he violated the provisions laid down u/s 223/287 BNS & 24/26 West Bengal Fire Service Act 1950.

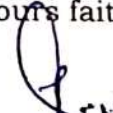

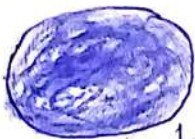
