I, SI Tanmay Kundu of New Jalpaiguri PS do hereby producing the arrested accused person namely Tinku Roy (34) s/o Lt Sukumar Roy of South Santinagar PS New Jalpaiguri Dist Jalpaiguri along with the following seized Fire crackers under proper seizure list viz;

- 1) Eighty Five (85) packets of king cobra electric fire crackers super power lanka crackers.
- 2) Twenty four (24) packets of Rhino power chocolate fire crackers each packet 10 pieces.

I, SI Tanmay Kundu of New Jalpaiguri PS do hereby submit a complaint to the effect that today on 19.10.25 at about 19:05 hrs received a source information, that one person without any valid permission or document made a stock of huge quantity of Banned Sound Fire Crackers in the from of high decibel sound making fire crackers at South Santi nagar Under New Jalpaiguri PS Dist- Jalpaiguri and selling the same items to various customers. Accordingly, I diarised the matter vide New Jalpaiguri PS, SPC GDE No.913, dated 19.10.25 and brought it to the notice of you, about the information and as per his direction myself along with C/1462 Sajan Tamang, VP-13 Jamirul Islam and others left office to work out the source information. At about 21:05 hrs on 19.10.25 we reached at South santi nagar Under New Jalpaiguri PS Dist- Jalpaiguri in the house of Tinku Roy and as per identification of source we held raid at that house and found that he was stock & selling the above noted banned Sound Fire Crackers in the from of high decibel sound making fire crackers as per schedule of West Bengal Pollution Control Board. On Being asked he disclosed his identity as mention above and On demand he failed to produce any valid licence or documents for stock & selling. During enquiry it could be learnt that one Tinku Roy (34) s/o Lt Sukumar Roy of South Santinagar PS New Jalpaiguri Dist Jalpaiguri sales the above noted fire crackers for making his wrong full gain.


Thereafter I searched and seized procedure from that place in presence of local witness namely Sudesh Kundu (48) s/o Lt Debesh Kundu of Baribhasa Under New Jalpaiguri PS Dist- Jalpaiguri and 2) Liton Dey (35) s/o Nikhil Dey of Bhaktinagar Under New Jalpaiguri PS, Dist- Jalpaiguri. During search of the house, I found huge quantity around 05 Kgs approx, as noted above of Banned Sound Fire Crackers in the from of high decibel sound making fire crackers for selling locally for making good profit out of these. The Seizure was made between 22:15 hrs & 22:45 hrs as he violated the provisions West Bengal Fire Service Act 1950. Then I arrested the above noted accused person after issuing proper memo of arrest and informing the ground of arrest.

Under the above circumstances I pray before you that a specific case may kindly be started against Tinku Roy (34) s/o Lt Sukumar Roy of South Santinagar PS New Jalpaiguri Dist Jalpaiguri and other appropriate acts and sections of law and arrange for investigation of the case.
