Sir,

With due respect, I am producing herewith one arrested accused person namely Rajat Dey (26) s/o Sambhu Dey of Ambari Business Colony, PO Kamarvita, PS Bhorer Alo, Dist - Jalpaiguri along with following seized fireworks /fire crackers under proper seizure list viz:

1. Two packets of "Rhino Power Chocolate Bomb" each containing 10 pieces of firecrackers. [Total 02 X 10 = 20 pieces].
2. Six packets of "Bullet Bomb" each packet each packet containing 10 pieces of fire crackers. [Total 6 X 10 = 60 pieces].
3. Ten packets of "Champions Flower pots Big" each packets containing 10 pieces of firecrackers. [Total 10 X 10 = 100 pieces].
4. Four packets of "Spiderman" firecrackers each packet containing 10 pieces [Total 04 X 10 = 40 pieces].
5. Eight pieces of "Masima Zoo Zoo Chutput" firecrackers each packet containing 10 pieces. [Total 08 X 10 = 80 pieces].
6. One packet of "Vadivels Colour Koti" firecrackers each containing 10 pieces [Total 01 X 10 = 10 pieces].
7. Twenty six packets of "King Cobra" firecrackers each packet containing 26 pieces. [ Total [ 26 X 26 = 676 pieces]

I, SI Sailesh Subba of Bhorer Alo Police Station, Siliguri Police Commissionerate do hereby lodged this written complaint to the effect that today on 16.10.2025 at 12.05 hours during special mobile duty vide Bhorer Alo PS GDE No. 539, Dated. 16.10.2025 received a source information that one person of Ambari has illegally stored huge quantity of banned fire crackers at his shop situated at Ambari Bartola under Bhorer Alo PS and selling the same to his customers. Accordingly I informed the matter to O/C Bhorer Alo PS and as per his kind order myself along with force conducted raid at the said shop and apprehended one person who disclosed his identity as Rajat Dey (26) s/o Sambhu Dey of Ambari Business Colony, PO Kamarvita, PS Bhorer Alo, Dist - Jalpaiguri. Further on being searched of his shop, the above noted seized firecrackers were recovered which was kept without any safety measures. On demand he could not produce any valid documents for procuring and storing the said firecrackers at his shop.

The above noted seized fire crackers are combustible in nature and endanger to human life and property and were procured and possessed without any precautionary and safety measure. So, I seized the above noted fire crackers under proper seizure list duly signed by the witnesses and arrested the above noted person after appraising him the ground of arrest. The seizure was made in between 12.25 hours to 12.35 hours. The whole process of seizure was videographed as per law.

Hence, I pray before you that a specific case may kindly be started against the above noted person namely Rajat Dey (26) s/o Sambhu Dey of Ambari Business Colony, PO Kamarvita, PS Bhorer Alo, Dist - Jalpaiguri under proper section of law and arrange for its investigation.
