Sir,

With due respect, I am producing herewith one arrested accused person namely Biswajit Mondal (M/38) s/o Late Narayan Mondal of Mehendiganj, P.O Manuagach, PS Bhorer Alo, Dist. – Jalpaiguri along with following seized fireworks /fire crackers under proper seizure list viz:

1. Fifty Five (55) packets of "Rhino Power Chocolate Bomb" firecrackers each packet containing 10 pieces of firecrackers. [Total 55 X 10 = 550 pieces]
2. Two Hundred and Fifty (250) packets of "King Cobra" firecrackers each packet containing 28 pieces of firecrackers. [Total 250 X 28 = 7000 pieces]
3. Five (05) packets of "JMD GAIK Flower Pot" firecrackers each packet containing 10 pieces of firecrackers. [5 X 10 = 50 pieces]

I, SI Sailesh Subba of Bhorer Alo Police Station, Siliguri Police Commissionerate do hereby lodged this written complaint to the effect that today on 17.10.2025 at about 12.05 hours while performing special mobile duty at PS area vide Bhorer Alo PS GDE No. 571, Dated. 17.10.2025, received a source information that one person at Ambari Bazaar under Bhorer Alo PS has illegally stored huge quantity of banned fire crackers at his shop and selling the same to his customers. Accordingly I informed the matter to O/C Bhorer Alo PS and as per his kind order myself along with force conducted raid at the said shop and apprehended one person who disclosed his identity as Biswajit Mondal (M/38) s/o Late Narayan Mondal of Mehendiganj, PO Manuagach, PS Bhorer Alo, Dist. – Jalpaiguri. Further on being searched of his shop, the above noted seized firecrackers were recovered which was kept without any safety measures. On demand he could not produce any valid documents for procuring and storing the said firecrackers at his shop.

The above noted seized fire crackers are combustible in nature and endanger to human life and property and were procured and possessed without any precautionary and safety measure. So, I seized the above noted fire crackers under proper seizure list duly signed by the witnesses and arrested the above noted person after appraising him the ground of arrest. The seizure was made in between 12.35 hours to 12.45 hours. The whole process of seizure was videographed as per law.

Hence, I pray before you that a specific case may kindly be started against the above noted person namely Biswajit Mondal (M/38) s/o Late Narayan Mondal of Mehendiganj, PO Manuagach, PS Bhorer Alo, Dist. – Jalpaiguri under proper section of law and arrange for its investigation.
