I beg to report that I, SI Srimanta s/o Lt Debi Prasad Chatterjee of Bhaktinagar PS under Siliguri Police Commissionerate lodged a written complaint against the above noted arrested accused person to the effect that on 19.10.25 at about 20.10hrs received secret source information from 2 No Jyotinagar under Bhaktinagar PS that one person have gathered huge quantity of band fire crackers in his street shop for selling the same for his designed customers. Diarized the information in GD vide Bhaktinagar PS GDE no-862 dated 19.10.25 and as per your kind instruction myself along with SI Yuel Lepcha, ASI Dipak Karmakar, ASI Dhurbo Misra, ASI Khagen Barman, and C/374 Debraj Biswas, all of Bhaktinagar PS left for 2 No Jyotinagar to work out the information. This refers to Bhaktinagar PS GDE No-863 dated 19.10.25.

At about 20.30 hrs we reached at 2 No Jyotinagar, sometimes after, being identified by the source our police party held raid and apprehended the above noted person and recovered the above noted articles from his possession. On demand he could not produce any valid documents/license in support of said fire crackers and also stated that he have gathered this firecrackers for selling the same to his designed customers for his wrongful gain without any valid documents or license violating the provision of law which may endanger human life and likely to cause hurt or injury human or property. Accordingly I seized the above noted fire crackers from the possession of accused Roshan Kumar-28yrs s/o Ram Chandra Singh of Bagmusha, PS Baishali, Dist Hazipur Bihar at present c/o Arun Singh of 2. No Jyotinagar PS Bhaktinagar Dist Jalpaiguri in presence of witness duly signed by them with proper auxio & videography and arrested him u/s 35 BNSS. (The seizure was made in between 20.55hrs hrs to 21.45hrs)

I therefore request you a specific case may kindly be started against the accused person namely Roshan Kumar-28yrs s/o Ram Chandra Singh of Bagmusha, PS Baishali, Dist Hazipur Bihar at present c/o Arun Singh of 2. No Jyotinagar PS Bhaktinagar Dist Jalpaiguri under proper section of law and arrange for its investigation.
