With due respect I, **SRI SANTOSH PRASAD**, S/o Sri Kanhai Prasad, resident of Near Saroj Bhandar, Durga Nagar, Ward No 40, S.M.C., P.O. Sevoke Road, P.S. Bhaktinagar, Dist- Jalpaiguri, Pin: 734001 in the state of West Bengal, would like to lodge this Written Complaint to the effect that on 19.10.2025 at about 02:30 AM early in the morning I went to Anil's Hotel situated at Near Anandloke Hospital, Sevoke Road for having some food and after reaching there I was having my food peacefully and three persons namely **Md. Anish** , **Johnty** and **one unknown** persons came at the hotel and they started abuse me without any just cause and reason but at that time I remained quite and after finishing my food I left the hotel and at about 03:00 A.M. I was coming back to my house from Payel More, ISKCON Road riding my bike at that point of time the above mentioned persons namely **Md. Anish**(Mobile No. 82932-12742), Son of unknown, resident of Lower Bhanu Nagar, Shahid Nagar More, P.O. Sevoke Road, P.S. Bhaktinagar, Dist- Jalpaiguri, Pin: 734001, **Johnty** and one **Unknown Person** forcefully stopped me near Sri Sri Vatika Apartment, ISKCON Road, and they pulled me to the narrow lane adjacent to Sri Sri Vatika Apartment and without any just reason they started to assault me by fists and blows very badly and they tried to strangle me by pressing my throat and they were continuously abusing me with filthy languages, I tried

my level best to rescue myself from their clutches but at the same the above mentioned **Md. Anish** snatched cash of Rs. 8670/- (Eight Thousand Six Hundred Seventy) Only and they further threatened me that they will kill me whenever they will get the chance, I was in mental trauma and had medicines and pain killers for the internal injuries sustained by me and thus late has caused in lodging F.I.R.

Therefore, I kindly request you to lodge this F.I.R. against the above mentioned persons and obliged thereby.
