Subject: Registration of FIR against four unknown miscreants (including one known by vehicle details) for offences under the BNS, including Sexual Harassment, Outraging Modesty, Attempted Kidnapping, Physical Assault, and Criminal Intimidation.

Respected Sir,

With due regards, I, SMT. BITHIKA CHAKRABORTY, resident of SF road, Near LIC office, Milanpally, Siliguri Bazar, Darjeeling, West Bengal - 734005, wife of Ashim Acharya, daughter of let-Narayan hereby lodge this written complaint detailing a shocking and violent series of incidents that occurred on the evening of 19th October 2025 at the YMA Ground, Siliguri. At approximately 8:25 P.M. on 19.10.2025, I was standing alone on the said ground, which was dark and deserted, speaking on my mobile phone. Suddenly, an unknown male, driving a Blue SKODA SUV (Registration No.: WB 74 BN 0134), approached me. Without any provocation, the man exited his vehicle, came up from behind me, and touched me obscenely and in a sexual manner. Following this, he verbally harassed me, making an explicit sexual solicitation by asking me for my "rate to sleep with him."

When I confronted the culprit and attempted to defend my person and honour, he became enraged and escalated the abuse by repeatedly using filthy, obscene, and sexually degrading slangs and words. Despite my resistance, he repeatedly touched me again in a sexual and perverse manner, resulting in my clothes being torn during the struggle. The accused then physically attempted to force me into his car, constituting an attempt to kidnap me from the location.

Fortunately, at this critical juncture, a male bystander and his mother, who were passing by, stopped to intervene and offer assistance. The male helper immediately called the Police Control Room to report the crime in progress. While the helper was communicating with the police, the primary accused made a call, and within minutes, three (3) additional unknown men arrived at the scene, joining the original culprit. This group of four men proceeded to viciously attack and physically assault the male helper, all while repeatedly shouting the intimidating threat that "they are local resident so they can do anything they want," along with continuing to use highly offensive and obscene sexual slangs directed towards us. The four accused then threatened us (myself, the helper, and his mother) with dire consequences, stating that they would "do anything with us" the next time they saw us.

Finally, in a blatant display of criminal intent, the accused persons drove their vehicle and attempted to run us over, compelling us to instantly move away to avoid being killed or severely injured. They only fled the scene when a small crowd began to gather due to the noise and commotion.

Now I m attaching the four of the accused persons picture along with the said vehicle picture with this FIR.

I, therefore, request you to investigate this matter with urgency and register an FIR immediately against the primary accused (known by vehicle number WB 74 BN 0134) and his three accomplices under law. I request prompt and rigorous action, including tracing the owner of the vehicle and apprehending all four culprits to ensure my safety and the safety of the witnesses, and to ensure justice is served.
