each other, then my said neighbours, noted above came
to our house at Durga Nagar Colony, Ward No. 4, P.S.-Siliguri
and started abusing me & my husband namely, (2) Md.
Samsum S/o Lt. Md. Habib, my son namely, (3) Md.
Samiul S/o Md. Samsum, my daughter namely (4) Khushi
too Khatun @ Putli Khatun & (5) Reekshana Khatun
w/o Md. Rizwan, all are of Durga Nagar Colony, in filthy
language, and when we protested, the above noted
alleged persons, took up Botam (wooden) logs
