Subject: Complaint regarding cheating and impersonation by two persons claiming to be police personnel in the name of "Naka checking"

Respected Sir,

I, Nandkishor Rathi, son of Late Ramswaroop Rathi, aged 70 years, residing at Malancha Apartment, behind Siliguri Police Station, Deshbandhu Para, Siliguri, and proprietor of a shop named "Shubhkamna" situated at Mahabirathan, Siliguri, beg to lodge this complaint as follows:

Today, i.e. 21 October 2025, at around 10:30 a.m., while I was returning from my shop to my residence on a rickshaw, just before reaching Siliguri Police Station beside the flyover, two persons stopped my rickshaw. They introduced themselves as police personnel and said they were conducting a "Naka checking" operation.

They asked me to produce my identity proof. Thereafter, they demanded that I hand over my gold Kada (bangle) and gold ring for checking. My Kada was a bit tight, so they applied oil and removed it from my hand. They then wrapped both items in a piece of paper, placed it in my pocket, and asked me to leave.

After moving a short distance, I checked the paper and found that the gold kada and ring had been replaced with duplicate items. I immediately realized that I had been cheated by two miscreants impersonating police personnel.

Both individuals were wearing caps and had ID-like cards hanging on their chest, which made them appear as genuine police officers.

The rickshaw puller Jaganath Singh of Jyoti Nagar W NO 4 of SMC. who was carrying me at that time is my regular service provider, and he usually parks his rickshaw near my shop. He can identify the culprits if required.

I therefore request you to kindly register my complaint, investigate the matter, and take necessary legal action for the recovery of my stolen articles and apprehension of the offenders.
