Chhetri of Matigara PS, Siliguri Police Commissionerate beg to state that on 22.10.2025 at 22:35 hrs, I received a secret source information that a gang of miscreants were assembled at Paribahan Nagar Parking under PS- Matigara, Dist.- Darjeeling with deadly weapons and making preparation for committing dacoity at Himachal Bihar under Matigara PS area. Accordingly, I informed the fact to you and diarized the matter vide Matigara PS GDE No-1141, Dated-22.10.2025. As per kind order at 22:40 hrs myself along with PSI Avijit Banik, ASI Chandra Prakash Adhikari, C/219 Sanatan Chitrakar, C/868 Sujal Roy, C/523 Sanjit Kundu all are of Matigara PS, Siliguri Police Commissionerate left for Paribahan Nagar, Parking under PS-Matigara, Dist- Darjeeling to work out the information in hand. This refers to Matigara PS GDE No- 1142, Dt- 22.10.2025. At about 22:50 hrs on 22.10.2025 we arrived at Paribahan Nagar Parking under Matigara PS. After arrival of the spot and as identified by the source we found that 11/12 persons were assembled in a abandoned shed at Paribahan Nagar, Parking, PS- Matigara, Dist- Darjeeling and they were whispering in a very low voice. Accordingly we cordoned the place properly and approach towards them very slowly and carefully. But seeing the police party they started to flee away but we managed to apprehended eight (08) persons of them. On interrogation the apprehended accused persons, they disclosed their name and identity as noted above (not verified) and also disclosed that they assembled there to commit dacoity in a house at Himachal Bihar under Matigara PS area. They also stated that others 03/04 associates were able to fled away from the spot by taking advantages of darkness.

On being searched of the apprehended accused persons, found the above noted articles. Accordingly, I seized the above noted articles under proper seizure list and arrested the above noted 08 (eight) accused persons under proper memo of arrest and observing all the formalities of arrest.
