Subject: Lodging of First Information Report regarding a severe motor vehicle accident resulting in severe head trauma and body injuries.

Sir/Madam,

I, the undersigned wish to report a serious motor vehicle accident that occurred, in which my husband - Prasanta Kumar Barman sustained severe body and head injuries. The details of the incident are as follows:-

⑤ Detailed description of the accident:

On 18/10/25 at approx. 11:30 am, my husband - Prasanta Kumar Barman was driving his scooter (Reg no - WB 73 N0181) at Saltani road. The offending vehicle, bearing registration no - WB 76 3974 driven by Rajesh Kumar Rajak opened his front driver side door without looking behind and at that same time my husband (Prasanta Kumar Barman) was driving past his vehicle. The door opened suddenly hitting his scooter and he slammed on the door of the vehicle and sustained severe head and body injuries. My husband was wearing a helmet at the time of the incident. My husband instantly suffered massive bleeding which came out of his ear. The locals present nearby, took him to nearby hospital i.e. Ridhi Healthcare Centre and got him admitted. The hospital staff informed me and I rushed to the hospital.

⑥ Details of injuries sustained:

Due to accident, my husband (Prasanta Kumar Barman) has sustained severe head injuries and also body injuries. His major injury is to his head which resulted in bleeding from his ears and blood haemorrhage in the brain. He is currently admitted in HDU at Ridhi Healthcare Centre since 18/10/25.

I was unable to lodge the FIR on the same day due to being busy with attending to the patient. I request you to kindly register this complaint as an FIR under the relevant sections of the law.
