Respected Sir,

With due respect, I SURAJ RAY, Son of Ratan Ray, aged about 23 years, resident of Santoshi Nagar, Ward No. 05, Near Vishnu Mandir, Siliguri, P.O and P.S- Siliguri, District- Darjeeling, West Bengal, PIN-734005 would like to state that on 18.10.2025 at about 04:00 am while I was out for my routine morning walk and had reached Macchli More, I noticed a few miscreants namely Ranjan Sahani, Md. Sriraj and more 02-03 persons standing on the road side and consuming alcohol in a public space. As I attempted to pass by, the said individuals obstructed my path. When I stopped and questioned them, then one boy namely Ranjan Sahani, resident of ward no 04, kacchra mart suddenly turned violent and attacked me with a knife on my face.

I received a severe injury on my face, and as I tried to protect myself, the same person attempted to stab me in the stomach with the clear intention of killing me. Fortunately, I managed to escape further harm and sought immediate medical attention. I was taken to Siliguri District Hospital, where I was treated and received eight (08) stitches on my face. That today when my elder brother namely Ajay Ray, who stays in Pradhan Nagar, Siliguri came to know about the said incident over the phone call, he came to our home at Santoshi Nagar and again he took me to the Siliguri District Hospital for necessary treatment. That the said alleged persons had come to know that my brother had took me to the hospital for treatment the said persons started threatening me and my elder brother that if I inform the police about such incidents then they will kill us.

That the alleged persons are very dangerous and criminal in nature and that they will not hesitate to kill me and my brother. The entire incident has left me physically and mentally traumatized and I request that a proper investigation be initiated at the earliest.

I urge you to kindly register an FIR under appropriate sections of law and take strict legal action against them.
