Subject: Complaint to lodge FIR against Santosh Prasad and his associates for multiple illegal criminal acts, including Stalking, Harassment, Criminal Intimidation, Illegal Trespassing, Sexual Assault and Attempt to Rape, Physical Assault, Molestation and Outraging of Modesty of Women and Theft.

Respected Sir/Madam,

I, Fiza Shamshad Ansari, daughter of Shamshad Ansari, aged about 20 years, am a permanent resident of Hamid Seth Chawl, Navi Basti, Kalyan Road, Near Apsara Cinema, Bhiwandi, District Thane, Maharashtra, Pin - 421302 and currently, I am residing at a rented accommodation along with my colleagues namely Farida Khatoon and Shila Das, at Iskcon Road, Near Vatika Apartment, Siliguri, West Bengal, would like to bring to your kind information and filing a complaint against Santosh Prasad, son of Kani Prasad, resident of Durga Nagar, Ward No. 40, Siliguri, District Jalpaiguri, West Bengal, Pin - 734001, and his unidentified associates, for multiple acts of Stalking, Harassment, Criminal Intimidation, Illegal Trespass, Sexual Assault and Attempt to Rape, Physical Assault, Molestation and Outraging of Modesty of Women and Theft as described below:

- 1) That approximately 15 days ago, Santosh Prasad approached me and made inappropriate and unsolicited advantages, asking me to be in a relationship with him but after recognizing his inappropriate behaviour and his apparent addictive nature, I firmly rejected his proposition. Despite my clear refusal, he continued to stalk and follow me, repeatedly attempting to make contact. Furthermore, he began threatening me, pressuring me to comply with his demands, this ongoing harassment has caused me significant distress and I feel unsafe due to his continued pursuit and intimidation.
- 2) That on **18.10.2025**, I informed the matter to the concerned officer at your respective police station. However, following this, Santosh Prasad again threatened me, saying that if I dared to lodge an FIR, he would disfigure my face with acid, this has caused me tremendous fear for my life and safety.
- 3) That on **21.10.2025** during the mid-night, at around **03:10 AM**, Santosh Prasad along with 04 of his associates forcibly entered our rented house and all of them were intoxicated state and appeared to have come with the intent to rape me and thereby he proceeded to sexually assault me, attempting to tear my clothes and made me semi-nude. However, due to the timely intervention of my room-mates, Farida Khatoon and Shila Das, the assault was thwarted and in retaliation, Santosh Prasad and his associates physically assaulted my room-mates, Farida Khatoon and Shila Das, molesting them and outraging their modesty, the accused struck both victims on their chests, causing their clothes to tear, and leaving them physically injured and emotionally traumatized. Nevertheless, during this incident, the accused persons looted valuables, including gold-chain and jewellery worth approximately **₹3,00,000/-** and cash amounting to **₹1,50,000/-** before fleeing the scene.
- 4) That the entire incident and criminal actions of Mr. Santosh Prasad and his associates have caused us significant harm and has been a traumatic experience for me and my room-mates, as we have been left feeling unsafe in our own home and we are living in constant fear for our safety and security, causing severe mental and emotional distress.

Therefore, I kindly request you to lodge the aforesaid complaint as FIR as per relevant sections of BNS and take immediate and necessary action to ensure our safety and security and to investigate the matter thoroughly and I humbly pray that Santosh Prasad and his associates be arrested for their criminal activities, including Stalking, Harassment, Sexual Assault and Attempt to Rape, Physical Assault, Molestation and Outraging of Modesty of Women and Theft.

Thank you for your attention and prompt action on this matter and I would be grateful for your intervention in ensuring that justice is served and that such crimes are prevented from occurring in the future.

I do hereby enclose the medical reports for your kind perusal and kindly let me know if further information is required from our side to facilitate the investigation procedure.
