Sir,

In producing herewith following seized articles viz, 1) Fourteen bottles of kingfisher strong beer, each containing 650 ml marked as exhibit A. 2) Eight bottles of Himalayan gold 60 up country spirit each containing 600 ml marked as exhibit B. with all connected papers.

I, ASI Dhruba Misra S/O Abani Misra of Bhaktinagar Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against 1) Premal Roy S/O Lt Padma Charan Roy of Simulguri, PO Salugara, PS Bhaktinagar, Dist Jalpaiguri and 2) Rina Roy D/O Premal Roy of Simulguri, PO Salugara, PS Bhaktinagar, Dist Jalpaiguri to the effect that Yesterday on 24.10.2025 at about 21.35 hrs I received a source information that one person is storing and selling liquor at his shop cum hotel located at Simulguri, under Bhaktinagar PS without any valid license. Accordingly, I informed the matter to the I/C PS and as per his kind direction I, along with SI Srimanta Chatterjee, SI Youel Lepcha, ASI Khagen Barman, ASI Dipak Karmakar, C/ 374 Debraj Biswas all of Bhaktinagar PS had been to Simulguri under Bhaktinagar PS to verify the veracity of source information. At 22:00 hours, we reached there, and as identified by the source, we had been to the house after seeing a police party; the owner of the house fled from the house.

Further being searched the above noted articles were found at the house, after conducting local inquiry I came to know that the above noted Premal Roy and Rina Roy of Simulguri are illegally storing and selling the illicit liquor without any valid license. Then I seized the above mentioned illegal illicit liquor under proper seizure list in the presence of witnesses after observing all sorts of formalities at the spot. The whole process of seizure was conducted between 22.10hr to 22.40hrs at the spot. The entire process of search and seizure was recorded under proper audio-video record as per norms.

I, therefore pray before your good self that a specific case may kindly be initiated against and the owner Premal Roy and Rina Roy under proper section of law and may arrange to cause its investigation for violation of the rules and norms of Bengal Excise Act.
