Sir,

In producing herewith one accused person named Krishna Kumar Rahut @ Papai, aged 24 years, s/o- Pabitra Kumar Rahut, resident of Rupsingjote, PS- Bagdogra, Dist- Darjeeling (Aadhar No. 6472 7411 0587) under custody along with following fire crackers under proper seizure list:

- (i) Thirty-four (34) packets Samim's Rhino Power' chocolate firecrackers, each packet contains 10 pcs: total- 340 pcs.
- (ii) Six (06) packets Samim's Rhino Power' chocolate firecrackers, each packet contains 12 pcs: total- 72 pcs.
- (iii) Fifty (50) packets King Cobra Electric crackers, each packet contains 28 pcs: total- 1400 pcs.
- (iv) One hundred and twenty-five (125) packets Pooja Electric crackers, each packet contains 28 pcs: total- 3500 pcs.

(Total weight: 11.290 KG)

I, ASI Munna Ahmed of Bagdogra PS, S.P.C, Dist- Darjeeling, do hereby lodge this written complaint against the above mentioned arrested accused person Krishna Kumar Rahut @ Papai to the effect that on 17.10.2025 at 20:35 hrs I received secret source information that a huge quantity of banned fire crackers is stored at the house of one suspect named Papai at Rupsingjote under Bagdogra PS jurisdiction and the same has been selling illegally from that house. Accordingly, I informed the matter to O/C Bagdogra PS and as per direction of O/C Bagdogra PS I along with SI Binup Mahato, SI Debabrata Kundu, ASI Amit Lama, C/1509 Sourav Roy Sarkar, CV/389 Janak Singh & CV/375 Jogesh Barman left for Rupsingjote to verify the veracity of secret source information. This refers to Bagdogra PS GDE No. 715 dated 17.10.2025. At around 20:55 hrs we reached at Rupsingjote. At around 21:00 hrs, being shown and indication by the source, we held raid at the house of the suspect and managed to apprehend one person and interrogated him. On interrogation he revealed his identity as Krishna Kumar Rahut @ Papai, aged 24 years, s/o- Pabitra Kumar Rahut, resident of Rupsingjote, PS- Bagdogra, Dist- Darjeeling. Then we searched the house. On search, the above mentioned banned firecrackers were recovered. I asked the detainee to produce any valid license/ document for storing & selling fire crackers. But he could not produce any such document. I informed him that he has disobeyed the orders of the Hon'ble Supreme Court of India vide Judgment dated 23.10.2018 in W.P(C) No. 728 of 2015 and directives of Hon'ble National Green Tribunal in O.A. No. 249/2020 dated 09.11.2020 and 01.12.2020 duly promulgated in all electronic and print media vide memo No. 321-3L/WPB-E(VI)/2020 dated 26/10/2021 of West Bengal Pollution Control Board that "... there shall be a complete ban on the sale and bursting of all kinds of fire crackers, except green crackers in the State of West Bengal, till further orders in this respect ...". He further confessed that he has been selling such type of fire crackers illegally from his shop for his wrongful gain. He also stated that he was acquainted with the fact that the sale and purchase of all type of fire crackers are banned this year as per order of the Apex Court. There is a reasonable ground that the alleged accused has been negligently and illegally selling those banned fire crackers without any valid license or permission endangering the human life and has also violated the Govt. order. Accordingly, I seized the above mentioned banned fire crackers under proper seizure list in presence of independent witnesses and arrested the accused person after observing all legal formalities and communicated him the ground of arrest in writing for violating the Govt. order and issued him Memo of Arrest in this regard. The entire process of search, seizure & arrest is done in between 21:02 hrs and 21:12 hrs on 17.10.2025 through audio-video electronic means using Govt. mobile App 'WB E-Shakshya' vide Evidence Certificate No. C-715-20120-20251017215812.

Therefore, I request you to lodge an F.I.R. against the arrested accused person named Krishna Kumar Rahut @ Papai, aged 24 years, s/o- Pabitra Kumar Rahut, resident of Rupsingjote, PS- Bagdogra, Dist- Darjeeling (Aadhar No. 6472 7411 0587) under proper section of law and arrange for its investigation.
