- ① I, Dibyendu Ghosh son of Lt. Dilip Ghosh, resident of Bihan More, behind Aquarium, lower Bagdogra, P.S. :- Bagdogra, hereby inform you that I was driving my car model no. - Hyundai I10, vehicle no. WB TY AK 4830. Suddenly a car model no. Tata Curve Blue colour vehicle no. WB 73 K 6040 has hit my car from backside and it was in a very high speed, near Kunalpur Tea Estate on 16/10/2025 at around 1.50 pm to 2.10 pm.
- ② It is to inform you that after getting a sudden hit from backside my chest struck on the steering of my car and my chest started paining badly. Please be informed there is also a certain pain on the back of my head.
