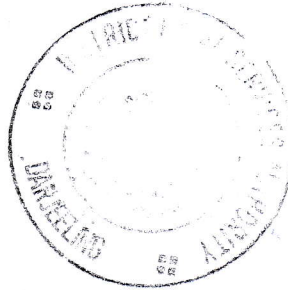

Respected Sir,

I Surabhi Sinha, I am the Office Master attached to DLSA, Darjeeling. I am writing this complaint on the instruction of Ld. Secretary, DLSA, Darjeeling as well as on the advice of SLA, West Bengal.

I would like to inform that in Victim Compensation Case No. 5/2021 arising out of POCSO Case No. 29(5)/2021, a Compensation amount of Rs. 5 Lakhs was sanctioned in favour of the Victim vide Sanctioned Order No. 1367/VC(SLSA-WB) Case No. 44/23 dated 20/05/2025 with a direction to deposit 75% of the awarded amount with the bank in Monthly Income Scheme in the name of the Victim for a period of 10 years with auto renewal option. However, in gross disobedience of the said order the mother of the victim has withdrawn the entire amount and inspite of several direction has refused to pay back the said amount or deposit it in any MIS Scheme and has threatened the staff of this office as well, to do whatever they please.

In this regard, it is extremely important to procure the said amount immediately in compliance of the direction of SLSA, WB. As such, I request your kind self to take necessary action in this regard so that the amount may be procured at earliest and the scheme of the Government may be followed without undue delay.

I request you to kindly regard this matter as a high priority case.
