Sir,


I Sri Debanjan Datta, S/o- Sri Ramendra Nath Datta, age 30 years, posted as Assistant Engineer (E) at Siliguri Town Division, WBSEDCL would like to inform you that on 25.10.2025 early morning theft of WBSEDCL materials has taken place from Dagapur Playground, where 11 kV Samar Nagar Feeder of Salbari 33/11 kV S/Stn of WBSEDCL is passing.

One no. Current Transformer (CT)- Potential Transformer (PT) combined unit, which is essential for boundary metering purpose has been stolen by unidentified miscreants from overhead Rail Pole Structure of WBSEDCL at Dagapur Playground (Snapshot enclosed). Due to this theft, WBSEDCL has incurred a financial loss of Rs. 74,403/- approximately.

Therefore you are requested to lodge the complaint & take necessary action accordingly.
