

1. That the petitioner permanently resides at the above mentioned address.





- 1. That the Petitioner was married to the Accused Person No 1 under Hindu rites and customs on 09.05.2024 at the parental house of the Petitioner which was duly arranged by the father of the Petitioner, situated at Chandani Danga, Majhiali, P.S. Chopra, Dist. Uttar Dinajpur, Pin-733207.
- 2. That during the marriage negotiations the Accused Persens demanded cash dowry of Rs.1,50,000/- (Rupees One Lakh Fifty Thousand Only), gold amounting Rs. 2,30,000/- (Rupees Two Lakh Thirty Thousand) only, Furniture amounting Rs. 1,54,000/- (Rupees One Lakh Fifty-Four Thousand) only along Almirah, bed, alna, Television, Sofaset, showcase, utensils, Bike worth Rs. 2,00,000/- (Rupees Two Lakh only) from the father of the Petitioner.
- 3. That after marriage, which took place under Hindu Rites and customs at the parental house of the Petitioner at Chandani Danga, Majhiali, P.S. Chopra, Dist. Uttar Dinajpur, Pin-733207, the entire dowry given by the Petitioner's family was kept in the custody of her in laws along with all her costly cloths and gifts received during marriage.
- That after marriage Accused Person No.1 brought the Petitioner at the house of the Accused Person No.1, situated at No. 1 Venchijote, P.O. New Chamta, P.S. – Matigara, Dist. Darjeeling.

5. That inspite of the in laws were never happy with the Petitioner and the Accused Persons constantly taunted Petitioner as she had brought sometimes of the insufficient dowry. Petitioner was treated like a servant from the very before me and the insufficient dowry. Petitioner was treated like a servant from the very before me and the insufficient dowry.

SAMBHUNATH & OlDhat soon after marriage the Accused Person Nos. 1 & 2 started to torture Notary (Gov. of India) he Petitioner both mentally and physically and pressurized the Petitioner to bring money from her father and when the Petitioner refused to comply their demands the Accused Person No. 1 bang her head on the wall, and started to beat the Petitioner mercilessly and also said that the parent of the Petitioner did not give sufficient dowry and demand more dowry from the Petitioner and on refusal the Accused Persons beat the Petitioner by fist and blows and by kicks mercilessly by pulling the hair of the Petitioner and after that they confine the Petitioner in a room and do not allow her to talk with anyone and also not provide sufficient food.









- 7. That the Accused Person Nos. 3,4 & 5 everyday visited the matrimonial house of the Petitioner everyday abused the Petitioner in filthy language and force the Petitioner to do all the household work and also demand dowry and cash amount of Rs. 3,00,000/- (Rupees Three Lakh only), but when the Petitioner express her father's inability to fulfill their demand the Accused Persons above named started to torture the Petitioner both physically and mentally by abusing the Petitioner with filthy languages and also beat the Petitioner mercilessly.
- 8. That the Accused Person Nos. 1 & 2 mostly came in drunken condition abused the Petitioner in filthy languages, physically assaulted the Petitioner by fists, blows and kicks and also tried to kill the Petitioner by wrapping the saree on the neck of the Petitioner. Moreover, the Accused Person No. 2 used to stare at the Petitioner with bad intention and also used to show the Petitioner inappropriate gesture.
- 9. That subsequently the Petitioner became pregnant and during the pregnancy the Accused Persons torture the Petitioner physically and also instigated the Accused Person No. 1.to beat the Petitioner and torture her.
- 10. That therefore out of the wedlock of the Petitioner and the Accused Person No. 1, one female child namely Harsita Singha, was born on 10.02.2025, after knowing about the birth of the female child the Accused Persons never ever took any information about the Petitioner during the delivery time as the Accused Persons never ever wanted the below me in which for Accused Persons were never happy nor the Accused Person No. 1 ever provided any maintenance towards the Petitioner and the infant baby.

- Shiguri. Darieeling 11. That due to the birth of a female child the torture increased upon the Petitioner in an aggravated form and the Accused Persons started to torture the Petitioner in humanly and also started to beat my infant baby brutally.
 - 12. That even after the lapse of few months nothing changed and the torture increased day by day and on 31.08.2025 the Accused person No. 1 came home in a Drunken condition, started to beat the Petitioner mercilessly with an wooden stick, by kicks and blows and also dragged the Petitioner on the floor by pulling her hair and ousted the Petitioner forcefully along with the infant child.





- 13. That after that the petitioner somehow went to Matigara D.H.P.C for treatment and return to her matrimonial house as the Petitioner had no other shelter then subsequently again on 01.09.2025 the Accused persons threw my infant child only with an intention to kill the infant female baby and when I protested, the Accused Persons started to beat the Petitioner mercilessly and forcefully drove out the Petitioner along with the infant child from matrimonial house, on that day the Petitioner and her minor female child rushed to Matigara D.H.P.C for their treatment.
- 14. That the Petitioner after this fearfully incident the Petitioner got scared as these persons as these accused Persons are very furious in nature and in this regard the Petitioner lodged an FIR before the Matigara Police Station on 03.09.2025, but the concerned Matigara Police Station refused to register the F.I.R of the Petitioner.
- 15. That thereafter finding no other alternative the Petitioner has made a written Complaint before the Commissionerate of Siliguri Metropolitan Police about the aforesaid incident on 09.09.2025, which was duly receive by the concerned authority on 09.09.2025, but no action has been taken yet against the aforesaid accused Persons
- 16. That the petitioner is a helpless lady and She is seeking justice before this Ld. Court by taking necessary legal action against the above named culprits as the Petitioner and the life of the infant child is in very much danger and they can any time attack the petitioner and may kill the Petitioner along with the infant female child.

That this petition is made bonafide and for the interest of justice.

Daneeting treat this complaint as F.I.R. and to take appropriate steps against the accused persons for committing the offences and investigate into the matter.
