I am informing you that on 24-10-2025  
around 3:30 PM opposite to my house near  
Sun Nursing Home my father Dilley Lepcha  
(Age - 79 years) son of Oyangking Lepcha of same  
residence. He was standing with his two pet  
dogs. Suddenly a two wheeler bike which was  
coming from BSF Kadamtala toward Flyover  
whichever R.C. no. WB-74A2-2082 (Pulsar)  
hit my father along with his pet dog with high  
speed. Due to which my father fell on the  
spot and incurred serious injuries in his head  
leg, chest, face, hand. And my pet dog died  
on the spot due to bike incident. And after this local  
people took him to Sun Hospital. Sun Hospital  
Authority after investigation, referred him to Higher  
Center (Paramount Hospital) as they declared serious  
injuries overall body. Now he is in ICU and in very  
critical condition. Regarding this incident fully  
responsible the person who was riding the bike  
recklessly.

Therefore I am requesting you take necessary  
action against the bike and bike rider. Yours faithfully
