That it was already a late evening and when we found that the aforsaid
customer namely Pratim Majumder took more than 30 minutes for a test drive of the
aforsaid Motor Vehicle and had did not turn up, we started calling him on his given
mobile number i.e. 7029520005 where after repeated calls he received our call and
requested us that he was stuck somewhere in his personal work and promised and
assured to return the aforsaid Motor Vehicle in the early morning of the next day and
will process the purchasing criteria but to an utter surprise after the very day of the
aforsaid incident he started making vague excuses to return and handover the
physical possession of the aforsaid Motor Vehicle to us. That we took every possible
ways to contact him both on his phone and also physically visited his place to recover
the aforsaid Motor Vehicle but went in vain and the aforsaid customer namely
Pratim Majumder is even threatening us that he will never return the aforsaid Motor
