Sir

In producing herewith following four arrested accused persons namely (1) Rajib Rava (22 yrs) S/o Babu Rava of Bhupendra Nagar, Near Radha Krishna Mandir, PS- Bhakti Nagar, Dist- Jalpaiguri (2) Rohit Kisku-24yrs s/o Lt Niren Kisku of Dakshin Palash, near Natun Bazar, PS Pradhannagar Dist Darjeeling (3) Sumit Roy-25yrs s/o Subhash Roy of Betgara, near Primary School, PS Bhaktinagar Dist Jalpaiguri and (4) Ajay Biswas-22yrs s/o Anup Biswas of Kholachand Fapri near Loknath Mandir, PS Bhaktinagar Dist Jalpaiguri along with following seized articles viz:

- 1) One iron made shutter breaking rod measuring approx 15 inches recovered from the exclusive and Conscious possession of Rajib Rava.
- 2) One iron made sharp cutting Chopper knife with wooden butt measuring approx 13 inch recovered from the exclusive and Conscious possession of Sumit Roy.
- 3) One screw driver measuring approx 9 (Nine) inch recovered from the exclusive and Conscious possession Rohit Kisku.
- 4) One Plus (Tools) measuring approx 8 ½ inch recovered from the exclusive and Conscious possession of Ajay Biswas.

I, ASI Khagen Barman s/o Noni Barman of Bhaktinagar PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted persons and 7/8 others to the effect that on 26.10.25 at 00:15 hrs received a specific source information that 12/13 miscreants have assembled at Roy colony, near Damping ground under Bhaktinagar PS, with deadly weapons and making preparation for committing dacoity to the passerby area. Accordingly I informed the matter to the I/C, Bhaktinagar PS and diarized the fact in General diary vide Bhaktinagar PS GDE No. 1163 dated 26.10.25 and as per order I along with SI Srimanta Chatterjee, SI Youel Lepcha, ASI Dipak Karmakar, ASI Ramesh Bitrikuti with force (K-38 PS Mobile) and C/374 Debraj Biswas all of Bhaktinagar PS, SPC, left for Roy colony, near Damping ground under Bhaktinagar PS to work out the information in hand vide GDE No-1164 dated 26.10.25.

At about 00.30 hrs we arrived at the at Roy colony near Damping ground as indicated by the source we noticed that 12/13 persons assembled there and they were whispering in a very low voice. Accordingly, we cordoned the place properly and very carefully and approach towards them very slowly and carefully but seeing the police party they started shouting police and started to flee away from the spot but we the police party after somehow managed to apprehended above noted 04 (four) of them with deadly weapons in their possession but 8/9 persons managed to fled away from the spot taking the advantage of darkness and open place. On being asked the apprehended accused persons disclosed their

name and identity as noted above. During interrogation they stated that they were present there and making preparation for committing dacoity to the passerby area. On search the above noted weapon of offence recovered from their exclusive and conscious possession.

On further interrogation they give different statement in different time and failed to give any satisfactory reply for their presence with deadly weapons in the middle of the night.

Accordingly, I seized the above noted weapons of offence from their exclusive and conscious possession under proper seizure list in presence of witnesses duly acknowledged by the accused persons and subsequently, arrested them under proper memo of arrest also informed them about ground of arrest in writing and observing all the formalities of arrest the whole search seizure was made on 26.10.2025 in between 00.40 hrs to 01.10 hrs the whole seizure was conducted under proper audio video record through apps.

Under the above noted fact and circumstance, I, therefore pray to you that a specific case under proper section of law may kindly be started against the arrested persons viz. (1) Rajib Rava (22 yrs) S/o Babu Rava of Bhupendra Nagar, Near Radha Krishna Mandir, PS- Bhakti Nagar, Dist- Jalpaiguri (2) Rohit Kisku-24yrs s/o Lt Niren Kisku of Dakshin Palash, near Natun Bazar, PS Pradhannagar Dist Darjeeling (3) Sumit Roy-25yrs s/o Subhash Roy of Betgara, near Primary School, PS Bhaktinagar Dist Jalpaiguri and (4) Ajay Biswas-22yrs s/o Anup Biswas of Kholachand Fapri near Loknath Mandir, PS Bhaktinagar Dist Jalpaiguri and 8/9 others also arrange for its investigation.
