With due respect, I SI Bapi Ch Dey s/o Late Nemali Ch Dey posted at Ashighar Out Post under Bhaktinagar P.S, SPC do hereby lodge this written complaint against the following miscreant persons named 1) Shiben Ghosh s/o Gobinda Ghosh 2) Gobinda Das s/o Late Pradip Das 3) Laxmi Das D/O Late Pradip Das all of Ashighar East Chayan Para under PS, Bhaktinagar along with and 5/7 other local inhabitants of Ashighar East Chayan Para, adjacent areas

The brief fact is that on 23.10.25 at night received a verbal information that one Raja Das s/o Late Pradip Das committed theft from one Barooyari Maa Kali Mandir located at Ashighar East Chayan Para and stolen away some gold ornaments of Goddes Kali ie i) one gold tikli ii) one forehead doga iii) Three tip. After received said information and as per source identification on 25.10.25 at night one Bikash Das @ Raja has been apprehended and brought him at Ashighar OP, for interrogation. During examine said Bikash Das @ Raja admitted his guilt that on 23.10.25 he stolen away the above noted gold ornaments from the Goddess Kali located at East Chayan Para and sold out the same to one Sanjib Roy jewelry shop owner located at Naresh More. During repeated interrogation he also assured us if he gets chance help police team to recover the stolen gold ornaments and identified the gold purchaser. At that time suddenly, at night while, I was engaged to working my official work at Ashighar Out Post, at approximately 23:25 hrs the above noted miscreants along with 5/7 others came at my office chamber and threaten me to handed over the miscreants Bikash Das @ Raja on their hand. Accordingly, I repeatedly asked them about the involvement of miscreants Bikash Das @ Raja but they paid no visit my any thing. Out of them one Laxmi Das and Shiben Ghosh continuously threaten me as well as used abusive languages against the police department and discharged me from my Govt. duties. Later on 26.10.25 around 00.05 hrs one Sri Shankar Karmakar s/o Kanai Karmakar of Ashighar East Chayanpara PS, Bhaktinagar Dist, Jalpaiguri came at Ashighar OP, and lodge a written complaint about the incident of theft of gold ornaments Goddess Kali from Baroyari Kali Mandir located at East Chayan Para and this refers Bhaktinagar PS Case No 1042 /25, Dated: 26.10.2025, U/S- 305 BNS 2023 has been registered.

Under the above-noted facts and circumstances, I, therefore, pray before your good self that a specific case under proper section of law may kindly be initiated against the 1) Shiben Ghosh s/o Gobinda Ghosh 2) Gobinda Das s/o Late Pradip Das 3) Laxmi Das D/O Late Pradip Das all of of Ashighar East Chayan Para along with and other 5/7 local inhabitants of Ashighar East Chayan Para, miscreants and request to arrange its investigation.
