I Sri Debanjan Datta, S/o- Sri Ramendra Nath Datta, age 30 years, posted as Assistant Engineer (E) at Siliguri Town Division, WBSEDCL would like to inform you that on 25.10.2025 around 9:30 PM at night, an accident occurred where the above said vehicle collided with a WBSEDCL 9M HTOH Pole near Roy Colony More in front of CP Greens Apartment where 11 kV BSF Feeder of Housing Board 33/11 kV S/Stn of WBSEDCL is passing.

Due to this accident, HTOH infrastructure of WBSEDCL has been damaged, leaving a good number of bonafide consumers of WBSEDCL in no power condition until restoration is completed. On account of this accident, WBSEDCL has to bear a total cost of Rs. 49,844/- approximately as network restoration charges.

Therefore you are requested to lodge the complaint & take necessary action against the miscreant accordingly.
