Sir

In producing herewith following five arrested accused persons namely (1) Haren Das @ Chittu (22 years) S/O Ranjit Das of Amtola Bottle Company, ward no 41, PS Bhaktinagar, Dist Jalpaiguri (2) Pinku Roy-35yrs s/o Lt Sushil Roy of Bhupendranagar, near Shiv Mandir ward no-42, PS Bhaktinagar Dist Jalpaiguri (3) Sanjay Biswas-22y s/o Anup Biswas Kholachand Fapri, near Loknath Manidr, PS Bhaktinagar Dist Jalpaiguri (4) Raja Barua-25yrs @ Shubham s/o Manik Barua of Prakashnagar near Swimming pool, ward no-42, PS Bhaktinagar Dist Jalpaiguri and (5) Rahul Mandal-20yrs s/o Raju Mandal of Sahani busty, ward no-43 PS Bhaktinagar Dist Jalpaiguri along with following seized articles viz:

- 1) One iron made knife with wooden butt measuring approx 9 ½ inches recovered from the exclusive and Conscious possession of Rahul Mandal.
- 2) One iron made sharp cutting Chopper knife with wooden butt measuring approx 12 inch recovered from the exclusive and Conscious possession of Haren Das @ Chittu. .
- One iron made knife with wooden butt measuring approx 9 ½ inch recovered from the exclusive and Conscious possession of Sanjay Biswas.
- 4) One iron made hammer measuring approx 11 inch recovered from the exclusive and Conscious possession of Raja Barua
- 5) One iron made hasko blade with wooden butt measuring approx 18 inch recovered from the exclusive and Conscious possession of Pinku Roy
- I, ASI Dipak Karmakar s/o Dulal Karmakar of Bhaktinagar PS, Siliguri Police Commissionerate do*hereby lodge this complaint against the above noted persons and 7/8 others to the effect that on 27.10.25 at 00:05 hrs received a specific source information that 12/13 miscreants have assembled at P.C. Mittal Bus stand, near Tower under Bhaktinagar PS, with deadly weapons and making preparation for committing dacoity to the passerby area. Accordingly I informed the matter to the I/C, Bhaktinagar PS and diarized the fact in General diary vide Bhaktinagar PS GDE No. 1212 dated 27.10.25 and as per order I along with SI Srimanta Chatterjee, SI Youel Lepcha, ASI Dhrubo Misra, ASI Ramesh Bitrikuti with force (K-38 I/III) PS Mobile) and C/374 Debraj Biswas all of Bhaktinagar PS, SPC, left for P.C. Mittal Bus stand, near Tower under Bhaktinagar PS to work out the information in hand vide GDE No-1213 dated 27.10.25.

At about 00.15 hrs we arrived at the at P.C. Mittal Bus stand, near Tower as indicated by the source we noticed that 12/13 persons assembled there and they were whispering in a very low voice. Accordingly, we cordoned the place properly and very carefully and approach towards them very slowly and carefully but seeing the police party they started shouting police and started to flee away from the spot but we the police party after somehow markaged to apprehended above noted 05 (five) of them with deadly weapons in their

ASI Sipale Kammakan 27/10/25 possession but 7/8 persons managed to fled away from the spot taking the advantage of darkness and open place. On being asked the apprehended accused persons disclosed their name and identity as noted above. During interrogation they stated that they were present there and making preparation for committing dacoity to the passerby area. On search the above noted weapon of offence recovered from their exclusive and conscious possession.

On further interrogation they give different statement in different time and failed to give any satisfactory reply for their presence with deadly weapons in the middle of the night.

Accordingly, I seized the above noted weapons of offence from their exclusive and conscious possession under proper seizure list in presence of witnesses duly acknowledged by the accused persons and subsequently, arrested them under proper memo of arrest also informed them about ground of arrest in writing and observing all the formalities of arrest the whole search seizure was made on 27.10.2025 in between 00.20 hrs to 00.50 hrs the whole seizure was conducted under proper audio video record through apps.

Under the above noted fact and circumstance, I, therefore pray to you that a specific case under proper section of law may kindly be started against the arrested persons viz. (1) Haren Das @ Chittu (22 years) S/O Ranjit Das of Amtola Bottle Company, ward no 41, PS Bhaktinagar, Dist Jalpaiguri (2) Pinku Roy-35yrs s/o Lt Sushil Roy of Bhupendranagar, near Shiv Mandir ward no-42, PS Bhaktinagar Dist Jalpaiguri (3) Sanjay Biswas-22y s/o Anup Biswas Kholachand Fapri, near Loknath Manidr, PS Bhaktinagar Dist Jalpaiguri (4) Raja Barua-25yrs @ Shubham s/o Manik Barua of Prakashnagar near Swimming pool, ward no-42, PS Bhaktinagar Dist Jalpaiguri and (5) Rahul Mandal-20yrs s/o Raju Mandal of Sahani busty, ward no-43 PS Bhaktinagar Dist Jalpaiguri and 7/8 others also arrange for its investigation.
