Respected Sir,

I, Sumit Saha, resident of 7, Rajani Kanta Sarani, Hakimpara, Siliguri-74001, Ward No.16, would like to bring in your notice that I was brutally physically assault by the members of G.T.S. Club at around 12:05 pm 24<sup>th</sup>. October, 2025 night near Kanchanjunda Stadium Opp. (Bikash Ghosh Memorial Swimming Pool) by 6-7 people out of which I know names of Rishab Gupta, Prabal Bose, Snehashish, Deva.

Honestly, I was physically assaulted because I had asked them to stop playing music at full volume at 4:00 am on 23/10/2025. I had even complained about the same at Panitanki Outpost after which they had sent a Patrolling Van to stop the nuisance but in vain, they tried to charge at those police officers. Last night, while returning home, they stopped me, physically assaulted me and threatened to murder me, rather shoot me. I am deeply affected by these goondagiri by these young men for stopping something which is unethical near two medical facilities. I need justice and severe punishment is requested. People simply keep their mouth shut because of the kind of treathning that they give around. Today, I was stopped in the middle of the road and been brutally assaulted. I would also like to bring this incident infront of Media and also request the police commissionarate to take legal action against the injustice

done to me as I had raised voice against something that isn't acceptable in a society where these are two medical facility, namely Mitra Nursing Home and

Therefore, I would request you to kindly serve me justice. Also, I would like to mention that one of the person, i.e. Rishabh Gupta had mentioned that he spoke to the I.C of Siliguri Police Station regarding me bring to stop them from Playing loud music at 4:00 am in the morning. I don't know if that is true or not and that's why I have informed the same in D.C.P office as well.

I shall be highly obliged if I get justice and these criminals are punished so that hooliganism doesn't prevail in Siliguri anymore.
