Sir,

In producing herewith two apprehended Child in Conflict with Law, namely, (i) Shubhajit Sarkar (16+yrs) s/o- Pradip Sarkar of House no 45, Durganagar Colony, ward no.04, PO+PS- Siliguri, dist- Darjeeling and (ii) Palash Sarkar (17+ yrs.) s/o Lt. Gopal Sarkar of do.

I, ASI Madhusudan Barman, son of Taranikanta Barman, of the Ashighar Out Post under the Bhaktinagar Police Station, am lodging this written complaint regarding the aforementioned minors. On October 27, 2025, at approximately 23:40 hrs, I received information from the duty officer at Ashighar Out Post about an accident near Lokenath Mandir on Eastern Bypass Road, within the jurisdiction of Bhaktinagar Police Station. After notifying the Officer in Charge of the Out Post, I proceeded to Lokenath Mandir with police personnel.

Upon arrival, I encountered a large gathering of people. During my inquiry, I learned that the minors were riding a Pulsar motorcycle with registration number WB-74-AX-2465, which collided with a scooter being ridden by Subrata Dutta, a resident of Ashighar Colony. As a result of the collision, Subrata Dutta and his family sustained injuries, and local residents promptly transported them to Siliguri District Hospital for treatment.

The local community was visibly upset by the incident and reportedly attempted to confront the minors in anger. To ensure their safety, I brought them to the Ashighar Out Post for safe custody. Thereafter, I conducted a thorough interrogation where they provided their names as stated above. They admitted to riding the motorcycle recklessly and dangerously, without valid documents, which led to the accident. When asked, they were unable to present any documentation for the motorcycle. Accordingly, I seized the motorcycle bearing Reg. No. WB-74-AX-2465 from their possession and formally apprehended the minors, Shubhajit Sarkar (16 years) and Palash Sarkar (17 years), under an official memo of apprehension and informed them of the grounds for their apprehension.

I therefore pray that a specific case under proper section of law may kindly be started against Child in Conflict with Law, namely, (i) Shubhajit Sarkar (16+yrs) s/o- Pradip Sarkar of House no 45, Durganagar Colony, ward no.04, PO+PS- Siliguri, dist- Darjeeling and (ii) Palash Sarkar (17+ yrs.) s/o Lt. Gopal Sarkar of do under proper section of law and arrange for its investigation.
