Sir,

With due respect, I am producing herewith the following seized articles viz :- (i) 05 (five) paper made cartoon containing 12 (twelve) bottles of "HAYWARDS BOLD" Strong Beer each cartoon (12 X 5= 60 bottles), each bottle containing 650ml. i.e total (60 X 650ml. = 39 ltrs), accordingly marked as Exhibit "A", "B", "C", "D" and "E" out of which one bottle from each cartoons of the same taken as sample for examination and marked as Exhibit-"A1", "B1", "C1", "D1" and "E1".

I ASI Biplab Kumar Das of Pradhan Nagar PS, SPC do hereby lodged this written complaint against the owner of tea stall situated at Gurung Busty more, PS Pradhannagar, Dist-Darjeeling to the effect that on 27.10.2025 during my evening mobile petrolling, I received source information that the owner of tea stall is selling illicit liquor randomly illegally infront of Gurung Busty More, PS Pradhannagar, Dist-Darjeeling and she stored huge quantity of illicit liquor at her said tea stall without any valid documents. Accordingly, I diarized the fact in General Diary vide Pradhan Nagar PS GDE No. 1499 dated 27.10.2025 and informed the matter you. As per your kind order and direction, I accompany with SI Goutam Mallik, SI Bandhan Roy, LASI Mithu Kabiraj and force all of Pradhan Nagar PS left for Gurung Busty More to work out the information with investigation kit by Govt vehicle. I briefed all the Police personnel sharing the information in hand and briefed them properly. At around 18:10 hrs we arrived at the said tea stall, and I along with other officers and force proceeded towards the tea stall, noticing the Police personeel approaching close the stall owner flew away form the spot. Further in the presence of independent witness we searched the intire stall and recovered 05 (five) paper made cartoon containing 12 (twelve) bottles of "HAYWARDS BOLD" Strong Beer each cartoon (12 X 5= 60 bottles). In local enquiry it found that the tea stall is owned by one Nitu Mahato @ Jagrotu W/O Jhagru Mahato of Sahani Patty, Cooliepara, ward No 01, PS Pradhannagar, Dist Darjeeling and she is running such type of illegal business of selling illicit liquor at her tea stall without any valid documents for her wrongful gain. As the said Nitu Mahato @ Jagrotu W/O Jhagru Mahato of Sahani Patty, Cooliepara, ward No 01, PS Pradhannagar, Dist Darjeeling violated the norms of Bengal Excise Act. I accordingly seized the above noted illicit liquor under proper seizure list in presence of witnesses and brought to the PS for further investigation. The whole process of search and seizure were made under the coverage of video graph in between 18:20 hrs to 18:35 hrs at the spot, through e-Sakho aap.

I, therefore pray before your good self that a specific case may kindly be initiated against accused namely Nitu Mahato @ Jagrotu W/O Jhagru Mahato of Sahani Patty, Cooliepara, Ward No 01, PS Pradhannagar, Dist Darjeeling, under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
