Darjeeling hereby inform you that today at about 5-30 -6 P.M. when my brother was going to his job at that time the following persons attacked him by rod, sharp weapons and lathis and my brother Sawan Paswan sustained injuries to his head and he started shouting and crying hearing his crying I along with my mother reached the spot at near the house of our councillor Sanjoy Pathak and saw that those person assaulting her by iron rod and lathi. That whenever we tried to save my brother from their attacked they also attacked me and my mother and assaulted us and also snatched golden mangal sutra from me and golden chain & nose ring from my mother. That whenever we started shouting local public came there and save our life. Sir the under mentioned persons are very dangerous in nature and they tried to kill my brother. That thereafter some persons and my husband took my brother Sawan Paswan to the Siliguri District Hospital and doctor advice to take him admission and he is now admitted to hospital.

Sir, the under mentioned persons are very dangerous in nature and they may do such type of incident again.

So, therefore I am requesting you kindly look into the matter and take immediate legal action against the persons as per your convenient.
