SUBJECT; WRITTEN COMPLAINT

I Manoj Kumar Sha son of Raghu Pati Sha would like to lodge a written complaint with effect that I MY Brother and staffs have been beaten up by some miscreants and One Rana Mahato.

It is pertinent to inform you that I have been running a bussines which deals in making all household iron and steel items. It is painful to inform you that One Rana Mahato wife of Umesh Mahato resident of Gyan Jyoti More, Lutiya jote, Near Pragati college ordered to deliver her a steel counter of weighing around 123 kg, and as per her demand I made a counter which costs around Rs. 43344(3.50 per kg), and three Aluminium sliding windows cost of which are around Rs. 14000 but when after making the abovementioned item as per her demand and design the abovementioned person declined to receive the items as she was not ready to make the payment at the time of delivery .She did not stop here, she along with some miscreants came at my shop and started abusing me in front of other customers and staffs present at my shop and when these miscreants were entering inside my house when my staff objected for the same and asked them to wait for a while as I was dealing with other customers but these miscreants were drunk and started beating me and my staffs with a sharp weapon in result of which all of us got injured .My elder brother Meghnath Shah who is suffering from various ailmaints asked these both persons to stop beating me on this pity issue and she tried to protect them they both started beating my brother as well. I was thrown on the floor my clothes were torned and they were abusing me and my brother and then one of them asked the other miscreants "eke bhetore niye chol dekhi koto goromi aache". When I got unconscious ,both of them were kicking everyone mercilessly and had also snatched three Gold chains and two gold locket (30 Grams,10 grams and 7.5 grams) worth of Rs. More than 4 lacs. When the public reached at spot then we were rescued by then public

It is painful to inform you that over a pity issue my wife and my daghters have been subjected to this inhuman treatment which I am unable to explain. I am a business person and most of the time I have to stay out of home in this heated situation safety of my family is a matter of concern for me.
