Respected Sir,

With due respect and humble submission, I ASI Sailes Das of Bhaktinagar Police Station, Siliguri Police Commissionerate would like to lodge a written complaint against the following persons:

(1) Dipu Saha s/o Dilip Saha of Vidyachakra colony, Ward no 44, PS Bhaktinagar, Dist Jalpaiguri, 2) Jagannath of fulbari, brother-in-law of Dipu, 3) Batal of Thakkar and others.

On 28.10.2025, at about 05:30 hours, I along with my forces namely C/820 Jayanta Roy, C/1540 Manas Das, LC/1980 Sapia Khatun, and LCV/494 Puspa Roy was performing Chhath Puja law and order duty at Dasrathpally/Laxmi Colony Mahananda River Ghat under Bhaktinagar PS vide MCC No. 5151/25, dated 27.10.2025. At that time the devotees were performing rituals at the ghat. In the mean time the abovenamed persons were found playing dice on an open ground nearby. I immediately warned them not to engage in such activities as it could disturb the devotees in performing their religious rituals and obstruct their free movement. However they ignored my instruction and started behaving in a rude and unruly manner. When I again directed them to leave the place but they began to disobey the direction.

As the public started to gather a chaotic situation began to develop. Hence I decided to apprehend them to prevent further disturbance. The situation escalated and upon noticing the commotion, nearby detailed officer ASI Sadhan Kumar Roy and his team reached the spot. Despite repeated warnings the above noted accused persons became violent and started tussling with the police personnel and dashed us. During the scuffle CV/1043 Pappu Roy received sustained injuries.

When I called for assistance from the K-38 Mobile Van the said accused persons fled the place. Later it came to light that the accused persons were identified as Dipu Saha s/o Dilip Saha of Vidyachakra colony, Ward no 44, PS Bhaktinagar, Dist Jalpaiguri (2) Jagannath of fulbari, brother-in-law of Dipu, 3) Batal of Thakkar and others.

Considering the gravity of the offence, I request you to kindly initiate specific legal action against the said accused persons and others involved in the incident.
