Sir,

With due respect and humble submission, I ASI. Nirmal Kumar Singha of Matigara P.S do hereby lodge this written complaint to the effect that today on 29/10/2025. I was deputed to perform mobile patrolling duty along with C/405 Samar Haldar and C/ 898 Satya Narayan Ghosh both are Matigara P.S since 07:55 hrs. vide Matigara P.S. M.C.C. No. 2883/2025, Dated 29/10/2025 and Matigara P.S. GDE No. 1446, Dated 29/10/2025. In course of said mobile duty I received a secret source information from reliable source that one vehicle is coming from Balasan River loaded with River bed Materials and proceeding towards Khaprail More, the vehicle is directly involved to procure river bed materials clandestinely and illegally. On receipt of such information, I informed the matter to I/C Matigara PS over mobile phone and as per his kind direction myself along with force rushed to Balasan River side and on way at Paulpara near Jishu Ashram under P.S. Matigara we found one blue colour Vehicle (Tractor) fitted with trolley and loaded with river bed materials in a high speed running towards Khaprail More Side, we tried to stop the said vehicle but seeing Police Mobile Van the driver/owner of said vehicle (Tractor) jumped from his vehicle and flee way towards Balasan River side kept the vehicle as abandoned. I along with force came close the vehicle and found the registration No of the vehicle is No. WB/73 G 4993 and trolley of the vehicle has loaded with river bed materials fully. It is crystal clear that the driver of the vehicle (Tractor) bearing Regn. No. WB/73 G 4993 procured river bed materials from somewhere clandestinely and illegally and was proceeding to sale the same to their designated customer for their wrongful gain. I asked the local people about the abandoned vehicle (Tractor) having Regn No. WB/73 G 4993 but they could not give any satisfactory reply. During enquiry Nobody came forward as claimant of the said loaded vehicle (Tractor). Accordingly, I seized the vehicle (tractor with trolley) bearing Regn. No. WB/73 G 4993 loaded with River Bed Materials on the spot i.e. Paulpara near Jushu Ashram, P.S. Matigara as abandoned condition by maintaining all formalities and prepared proper seizure list in presence and authenticated by independent witnesses. Subsequently I brought the seized vehicles to Matigara P.S and kept at P.S Compound. The whole process of Seizure was filmed in Mobile phone and preserved in a pen drive and it was done in between 14.08 hrs. to 14.14 hrs. on today i.e. 29.10.2025.

I therefore pray before you that a specific case under proper section of Law may kindly be registered against the accused driver as well as owner of the seized vehicle bearing no. Regd No. WB/73 G 4993 and arrange for its investigation.
