Subject: Complaint

Respected Sir,

I, Antara Roy, Wife of Sudipto Sengupta, resident of Flat 1-1A, Block 1, Upwan Apartment, Uttorayon, Siliguri, Pin- 734010, District- Darjeeling would like to inform you that I was married to Sudipto Sengupta, Son of Tapan Kumar Sengupta, resident of Flat 1-1A, Block 1, Upwan Apartment, Uttorayon, Siliguri, Pin- 734010, District- Darjeeling, on 11th May, 2015 as per Hindu rites and customs at Lucknow. That my husband being a doctor, hefty amount of Rs. 25,00,000/- was demanded by my in-laws, as dowry. That my parents could arrange an amount of Rs. 15,00,000/- as there were several other expenses in the marriage and gave the said amount to my parents-in-law in cash. That still my in-laws were not happy with the said amount and said that they incurred lot of expenses behind the education of their only son and this amount is nothing.

That apart from this, I was gifted with gold jwelleries by my parents and my relatives and friends as my stridhan. That the reception of my marriage took place at Jalpaiguri and after reception ceremony I was made to handover all my gold jwelleries to my mother-in-law as per instruction of my husband and mother-in-law as they stated that they will keep the same in safe custody in their joint bank locker at Jalpaiguri. Initially I could not gather their evil intention but later I realised that it was to deprive me of my stridhan as my husband and mother-in-law never allowed be to wear my jewelleries whenever I required it to wear and they made excuses on one or the other pretext. I was kept deprived of my stridhan.

That I stayed at Jalpaiguri with my parents-in-law for around six months and during that time my parents-in-law even used to taunt me and humiliate me talking bad things about my parents and they used to criticize that sufficient dowry was not given at the time of marriage.

That in the year 2017 I shifted to Siliguri with my husband and resided in rented premises. That I noticed that my husband is arrogant and short tempered and he criticized me taking my looks, my dress code, etc and even yelled at me in front of his parents, relatives and friends on petty issues or no issue at all. Slang was daily course. That I was compelled to handover my salary. He used to tell me that my parents have not taught me how to be a good wife. That I tolerated all this silently thinking that with time things will be normal.

That subsequently my husband insisted me to buy a flat and asked me to demand money for the same from my parents but I refused to do so as he already incurred lot of expenses in the marriage and I did not want to bother them. That my husband threatened me that he will sell my gold jewelleries and buy the flat. He compelled me to take loan from Axis Bank in my name to buy the flat at Flat 1-1A, Block 1, Upwan Apartment, Uttorayon, Siliguri, Pin-734010, District- Darjeeling, which is presently my shared household and I used to pay EMI in order to satisfy him. That the said flat was bought in our joint names, although my husband wanted to register the flat in his name only.

That in the meantime I became pregnant and could not continue my job as a doctor because of some health issues and on 13th January, 2020 I delivered a female child. That even after birth of child, my husband's behaviour did not change and my relationship with my husband became more strained because of his extra-marital affair with Dr. Sharmi Dey. That I have caught my husband and Sharmi Dey in an intoxicated state in a room with all lights turned off on a Kashmir trip in November, 2023. That my husband used to talk with Sharmi over phone until late hours of night in a separate room.

That subsequently my husband used to tell me that he is tired of me as I am good for nothing and insisted me to give divorce to him. That I suffered from depression and suicidal thoughts because of denial attitude of my husband and closeness of my husband with Sharmi Dey. That my husband forced me to sign on some divorce papers and he filed mutual divorce case although I never met any lawyer for the purpose of filing the case. That when I refused to go to court for mutual divorce, he threatened me and my mother that he will forcefully take the custody of my child.

That my parents-in-law used to come from Jalpaiguri and stay with us in my said flat. That when I told about such tortures to my mother-in-law, she blamed me and asked me to leave my flat/shared household. That not being able to bear day to day tortures, I went to my parental house at Lucknow during October, 2024 and informed about the tortures to them. That my parents requested my husband and parents-in-laws not to torture me or split marital relation taking into consideration the welfare of my small child. But the behaviour of my husband did not change. That my mother-in-laws blocked all the maid and drivers from entering the flat/shared household and I was left alone to manage my work and my child. Such situation was created in order to compel me to leave my matrimonial house.

That as I had night shifts in connection with my work in medical college, I temporarily took a rented flat near medical college so that I could take better care of my child and also for the reason so that my husband could realise his fault when I am little away from him.

That however, my parents kept on insisting me to return to my flat/matrimonial house with the child and for the sake of my child I returned to my matrimonial house to talk with my husband. That on 28.10.2025 I entered my flat at Uttorayon. That I was surprised to see that my husband had kept several condoms of current date. That I realised that my husband was having illicit physical relationship with Sharmi and others in my absence.

Not being able to bear such trauma, I called my mother-in-law and informed her about the same and asked her to return my gold ornaments (having approx. value of Rs. 50,00,000/-) which she has kept in a joint locker with my husband. But she blatantly refused to return the same and threatened me of dire consequences if I do not leave the flat. She told me that the flat belongs to my husband and I have no right over it.

That I am fearing physical harm at the hands of my husband or some other person engaged by him. There is a threat to my life and if anything happens to me, my husband and mother-in-law will be liable for the same.

I therefore request you to inquire into the matter and take necessary action against my husband and parents-in-law.
