#### Respected Sir.

I, CA G.S. Hora, presently carrying on practice from 2nd Floor, Shelcon Plaza, Sevoke Road, Siliguri, wish to lodge a complaint regarding fraudulent and malicious misuse of my name, forged signature, and my old office address.

On 23rd September 2025, I received by return post an envelope that had been undelivered and returned to my present address. On opening the envelope, I was shocked to find a letter falsely written in my name with partly incorrect designations, addressed to high constitutional authorities, containing baseless allegations against certain public officials.

The fraudulent letter carried my name and the old office address is Mia Garage Building, Hill Cart Road, Siliguri (vacated nearly 28 years ago).

Above address is no longer connected with me or my professional office, yet have been mischievously used by unknown persons to dispatch this fabricated letter, clearly with the intention of maligning my reputation.

Importantly, my signature has also been forged in a completely different style than the way I ordinarily sign. This establishes clear evidence of impersonation and criminal intent.

I categorically state that I have no connection whatsoever with the contents of the said letter, nor have I authorised anyone to write or send any such communication in my name. This is a clear case of forgery, impersonation, and malicious misrepresentation by persons attempting to misuse my name, goodwill, and professional standing.

### Request for Action:

 Kindly register this complaint and treat it as a formal FIR against the unknown persons responsible.

 Initiate investigation into the source of the forged letter, forged signature, and the use of my name and old address.

3. Verify the postal dispatch records and handwriting/printing involved so as to identify and take strict action against the culprits.
